A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO PURCHASE 0.779 ACRES OF RIGHT-OF-WAY ON MINK STREET AND BROAD STREET

WHEREAS, the City of Pataskala (City) was awarded an Ohio Public Works Commission (OPWC) grant to make improvements at the Mink Street and Broad Street intersection; and

WHEREAS, in order to complete the planned improvements at the Broad Street and Mink Street intersection, the City must acquire additional right-of-way; and

WHEREAS, it is necessary to purchase 0.779 acres of right-of-way at the southeast corner of the Broad Street and Mink Street intersection for the project as provided in the attached exhibits; and

WHEREAS, the project budget includes funding to purchase right-of-way.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS CONCURRING THAT:

<u>Section 1:</u> The City Administrator is hereby authorized to purchase .779 acres of right-of-way from James P. Shaffer at the southeast corner of the Broad Street and Mink Street intersection in an amount not to exceed \$40,000.

Section 2: This Resolution shall become effective from and after the earliest period allowed by law.

Thence North 03 degrees 42 minutes 36 seconds East, a distance of 67.60 feet along the westerly line of said Shaffer 6 acre Parcel Three to the intersection with the existing Right-of-Way centerline of Broad Street at the northwest corner of said Shaffer 6 acre Parcel Three, being 0.00 feet right of Broad Street Centerline Station 114+86.25;

Thence North 77 degrees 46 minutes 01 seconds East, a distance of 892.26 feet along the northerly line of said Shaffer 6 acre Parcel Three, and along the existing Right-of-Way centerline of Broad Street to the intersection with the existing Right-of-Way centerline of Mink Street (County Road 41) at the northeast corner of said Shaffer 6 acre Parcel Three, being 0.00 feet right of Broad Street Centerline Station 123+78.51;


