RESOLUTION 2022-058

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH AMERICAN STRUCTUREPOINT, INC. TO PERFORM ENGINEERING DESIGN AND BIDDING SERVICES FOR THE VINE STREET TRUNK SEWER IMPROVEMENTS PROJECT

WHEREAS, the City of Pataskala maintains and improves stormwater systems and related infrastructure within the City; and

WHEREAS, the City of Pataskala has determined it is necessary to make stormwater improvements along Vine Street ("the Vine Street Trunk Sewer Project") in order to mitigate street flooding that occurs within the project area; and

WHEREAS, the Vine Street Trunk Sewer Project will include stormwater improvements along Vine Street, leading from an existing manhole in Vine Street north for approximately 1000' to Linda Avenue, then west for approximately 600' to an existing catch basin; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to design and construct these improvements; and

WHEREAS, the City solicited qualifications for engineering in a City-wide RFQ; and

WHEREAS, the engineering firms that submitted for the RFQ were ranked for this project; and

WHEREAS, American Structurepoint, Inc. scored the highest in this ranking process; and

WHEREAS, Council for the City of Pataskala wants to contract with American Structurepoint, Inc., who submitted a proposal in the amount of \$49,500.00 for these services; and

WHEREAS, funding for design of this project is included in the 2022 budget as project SVC-22-004.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF

MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Forty-Nine Thousand Five Hundred Dollars and No Cents (\$49,500.00), with American Structurepoint, Inc. to perform the engineering design and bidding services for the Vine Street Trunk Sewer Project.

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3:</u> This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
