RESOLUTION 2022-063

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT FOR THE ADMINISTRATION OF HEALTH AND ENVIRONMENTAL SERVICE AND AFFAIRS WITHIN THE GEOGRAPHICAL JURISDICTION OF THE LICKING COUNTY, OHIO COMBINED GENERAL HEALTH DISTRICT**

***WHEREAS***, R.C. 3709.01 provides that each city within the State of Ohio constitutes a health district known as a “city health district” and the townships and villages within each county are combined into a health district known as a “general health district”; and

***WHEREAS***, R.C. 3709.07 authorizes one or more city health districts to unite with a general health district in the formation of a single district; and

***WHEREAS***, the Newark City Health District, the Heath City Health District, the Pataskala City Health District, and the Licking County General Health District previously, with the support of the Licking County Board of Commissioners, previously entered into an agreement establishing a single combined general health district; and

***WHEREAS***, the current agreement for the administration of health and environmental services and affairs within the combined general health district will expire on January 1, 2023, and

***WHEREAS***, the Village of Johnstown was certified as a city by the Ohio Secretary of State, and the Johnstown City Health District agrees to establish a single combined general health district; and

***WHEREAS***, the member districts of the combined general health district now want to enter into a new agreement for the administration of health and environmental services and affairs within the combined general health district, which shall go into effect on January 1, 2023 and include the city of Johnstown, in order to replace the current agreement on its expiration date.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** The City Administrator is hereby authorized and directed to execute an agreement,

in substantially the same form and content as the Agreement attached hereto as Exhibit A and incorporated herein by reference, with the Cities of Newark, Health, and Johnstown as well as the Licking County District Advisory Council.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
