**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT WITH MOTOROLA SOLUTIONS TO PURCHASE NINETEEN BODY-WORN CAMERAS AND EVIDENCE MANAGEMENT SOFTWARE**

*WHEREAS*, the City of Pataskala Division of Police has a continuing duty to provide efficient and effective service to the residents and businesses of the City as well as the traveling public that passes through the City; and

*WHEREAS*, the City of Pataskala Division of Police currently has thirteen body-worn cameras which were purchased in 2018. Because these camera are used often, the Division of Police can use only five of the thirteen cameras at any one time; and

*WHEREAS*, the City of Pataskala Division of Police wants the City to purchase an additional nineteen body-worn cameras and evidence management software from Motorola Solutions under a 5-year contract; and

*WHEREAS*, the total cost of the 5-year contract is \$62,980.00. However, payments will be divided equally over a 5-year period. Therefore, the amount due during the 2022 budget year is \$13,796.00 and the remaining payments for 2023 to 2026 will be \$12,296.00; and

*WHEREAS*, the City of Pataskala Division of Police will purchase these body-worn cameras from Motorola Solutions as part of the State of Ohio Competitive Purchasing Program; and

*WHEREAS*, the costs for the years 2023, 2024, 2025, and 2026 will be incorporated as part of the Capital Improvement budget; and

**NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ITS MEMBERS PRESENT CONCURRING THAT:**


Section 1. Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute an agreement, consistent with Quote CPE-0674-04, with Motorola Solutions to purchase 19 body-worn cameras and evidence management software for an amount not to exceed a total of \$62,980.00.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
