COUNCIL MEETING

August 1, 2022

The Council of the City of Pataskala met in regular session on August 1, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Epperson, Hampshire, Galik, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Lee made a motion to appoint Amy Dandurand to the 3rd Ward Council Vacancy. Seconded by Galik. Roll Call: Walther-no, Epperson-yes, Hampshire-yes, Galik-yes, Lee-yes, and Carter-yes. Mayor Compton declared the motion passed.
