RESOLUTION 2022-077

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ENTER INTO A CONTRACT WITH LOCAL WASTE SERVICES, LTD. FOR THE EXCLUSIVE CONTRACT FOR RESIDENTIAL REFUSE AND RECYCLING COLLECTION IN THE CITY OF PATASKALA

WHEREAS, in 2019, the City of Pataskala advertised for competitive bids for its residential garbage collection. Once these bids were opened, it was determined that Local Waste Services, Ltd. was the lowest and best bid; and

WHEREAS, the City of Pataskala then entered into an exclusive 3-year contract for residential collection, transportation, and disposal of garbage, refuse, recyclables and yard waste with Local Waste Services. The 2019 Contract will end on September 30, 2022; and

WHEREAS, under the terms of the 2019 Bid Specifications and its 2019 Contract, the City of Pataskala reserved the right to waive bidding and to negotiate a new subsequent 3-year contract with the selected hauler at the completion of the initial term; and

WHEREAS, Local Waste Services, Ltd. requested a new 3-year contract with the following pricing: Years 1 and 2: \$20.63 base rate (\$1.88 more per month per resident than current agreement, which has been flat for 3 years); Year 3: \$21.87. All other terms and conditions remain the same; and

WHEREAS, Council for the City of Pataskala now wants to exercise its right to not seek bids and enter into another 3-year contract with Local Waste Services.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> The City Administrator is hereby authorized and directed to enter into a 3-year contract with Local Waste Services, Ltd. for the exclusive franchise in the City of Pataskala for

residential collection, transportation, and disposal of garbage, refuse, recyclables and yard waste in the following amounts:

- ❖ In Year One, Base Bid, including the cost of the cart: \$20.63; Senior Discounted Rate: \$18.57
- ❖ In Year Two, Base Bid, including the cost of the cart: \$20.63; Senior Discounted Rate: \$18.57
- ❖ In Year Three, Base Bid, including the cost of the cart: \$21.87; Senior Discounted Rate: \$19.68
- ❖ Cost of an additional waste cart per month: \$3.00

<u>Section 2</u>: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3</u>: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
