RESOLUTION 2022-094

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A DESIGN MODIFICATION CONTRACT, WITH VERDANTAS, TO PERFORM ADDITIONAL ENGINEERING DESIGN FOR THE PATASKALA SAFE TRAVEL PLAN PHASE III PROJECT

WHEREAS, the City of Pataskala maintains and improves public roadways, bridges, and infrastructure within the City; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to provide safe travel for pedestrians along and across public roadways within the City; and

WHEREAS, on July 15, 2019, Council for the City of Pataskala approved Resolution 2019-056 and thereby authorized the design of the Pataskala Safe Travel Plan, Phase III Project in the amount of \$20,800.00; and

WHEREAS, the City of Pataskala received federal "Earmark" funding for the project in the amount of \$135,000. However, additional survey and design work must be performed to satisfy the federal funding requirements; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to perform this additional work as well as expand the project to take full advantage of the additional federal funding. To do so, Council for the City of Pataskala needs to execute two design modifications with Verdantas (\$2,500.00 and \$12,500.00) for a new total design contract value of \$35,800.00; and

WHEREAS, funding within the 2022 budget is available for this work.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute two design modifications for a total project amount not to exceed Thirty-Five Thousand Eight Hundred Eighty Dollars and No Cents (\$35,800.00), with Verdantas to complete the engineering design and bidding services for the Pataskala Safe Travel Plan, Phase III Project.

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3:</u> This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
