#### PROPOSED FINANCING TERM SHEET

The following financing terms are being proposed by the Ohio Department of Transportation to the Licking County Transportation Improvement District, City of Pataskala, and Etna Township. These terms may be adjusted as needed based upon mutual agreement of all parties. The Ohio Attorney General will ultimately opine to the terms of this agreement. The information contained in this term sheet is confidential and proprietary.

#### I. PROJECT INFORMATION

The Licking County Transportation Improvement District (the "Borrower" or "LCTID") has requested that the Ohio Department of Transportation (the "ODOT") State Infrastructure Bank (the "SIB") finance a portion of the public improvements located on Refugee Road between Mink Street and Etna Parkway (the "Project Site") along the border of Etna Township (the "Township"), Ohio and the City of Pataskala (the "City"), Ohio. Public improvements include 1.2 miles of roadway reconstruction, the widening of Refugee Road from two lanes to three lanes, and the construction of roundabouts at the project termini of Etna Parkway and Mink St. The existing pavement will be reconstructed from a 20 ft chip seal to a structure that can accommodate current and future growth of truck traffic with origins and destinations to several logistics facilities (the "Public Improvements" or "Project"). The centerline of the road splits the jurisdictions of Etna Township and the City of Pataskala. The total Project costs are estimated to be \$11,210,000. ODOT will provide a Title 23 Fund, Direct Loan in the amount of \$7,000,000 (the "SIB Loan"). The remaining Project costs will be financed through other sources (the "Other Sources") described below.

**Loan Repayments:** 

There will be no interest assessed on the loan from the date of closing through the last day of the 12<sup>th</sup> month. From the first day of the 13<sup>th</sup> month after closing through final maturity, the interest rate will be 3.0%. From month 13 through month 24, interest due on the loan will accrue and be added to the principal of the loan. The accrued interest amount is estimated to be \$210,000. The Borrower will be required to make principal and interest payments commencing on the first day of the 31<sup>st</sup> month after the Closing Date. The interest amount due, in arrears, will be based upon the outstanding principal amount of the loan from time to time. The projected principal and interest payments are estimated in Schedule II.

**Prepayment of Loan:** 

Prepayment of the State loan, in whole or in part, will be at the option of the Borrower. Any prepayment of the loan prior to the 36<sup>th</sup> month following closing will be subject to a 3.0% premium.

Etna Township or City of Pataskala may prepay its outstanding obligation after the 36<sup>th</sup> month. If a prepayment is made, the like amount will be deducted from the outstanding loan amount and their obligation will be reduced. ODOT will generate an updated loan repayment schedule upon a prepayment event.

**Source of Repayment:** 

#### **Etna Township (the "Township")**

Etna Township will agree to pledge Non-Tax Revenues (the "NTR") and all JEDD 1, JEDD 2, JEDD 3, JEDD 4, JEDZ 1 and JEDZ 2 revenues (the "JEDD/Z Revenues") together the JEDD/Z Revenues and NTR will be called (the "Pledged Repayment Source") to repay the SIB loan.

The Repayment Sources for the Township have historically been \$1,878,861, \$1,510,680 and \$1,972,926 in 2019, 2020 and 2021 respectively. The Township expects to receive a minimum of \$1,500,000 per year going forward.

### **Pledged Revenue Debt Covenant:**

Etna Township will agree to subordinate any future Pledged Repayment Sources if in any one calendar year (as projected) the expected Pledged Revenue Sources generated when divided by the scheduled annual debt service of all outstanding obligations secured by the Pledged Revenues are equal to or less than 1.50.

In addition, when developing an annual budget, the Township will first budget to pay all ODOT debt service, prior to budgeting other Pledged Repayment Sources. The Township will also agree to use all legally available funds to repay the SIB loan if the Repayment Source is insufficient to make scheduled SIB Loan Repayments as required.

### The City of Pataskala (the "City")

The City will agree to pledge its annual Income Tax receipts as (the "Pledged Repayment Source") to repay the SIB loan. City revenues are depicted below.

#### **Pledged Revenue Debt Covenant:**

City will agree to subordinate any future Pledged Repayment Sources if in any one calendar year (as projected) the expected Pledged Repayment Sources generated when divided by the scheduled annual debt service of all outstanding obligations secured by the Pledged Revenues are equal to or less than 1.50.

In addition, when developing an annual budget, the City will first budget to pay all ODOT debt service, prior to budgeting other Pledged Repayment Sources. The City will also agree to use all legally available funds to repay the SIB loan if the Repayment Source is insufficient to make scheduled SIB Loan Repayments as required.

#### **Guarantor's Payment Amounts:**

Etna Township has been allocated 50% of the payment amount due on the outstanding SIB Loan from time to time. The City of Pataskala has been allocated 50% of the payment amount due on the outstanding SIB Loan from

time to time. A detailed breakdown of the amount due by Etna and Pataskala is shown in Schedule II.

The City and the Township will provide appropriate resolutions approving SIB borrowing and the revenue pledges for the repayment of the SIB Loan debt service and fees.

**Intergovernmental Agreement:** The Intergovernmental Agreement is executed between

the LCTID, City of Pataskala and Etna Township.

Construction Contract: Provide an executed construction contract or another

acceptable contract agreement, if applicable, acceptable to ODOT for Project construction prior to the drawdown

of the SIB Loan.

**Agree to Fund Project** 

Costs Overruns: The City and Township will agree to fund Project cost

overruns on a 50/50 basis.

Prevailing Wage: Pay prevailing wages on all Public Improvements

construction contracts to be funded with the SIB Loan.

**Disbursements:** All disbursements of SIB Loan proceeds will be approved

by ODOT.

**Environmental Approvals:** All required environmental approvals must be acceptable

to ODOT.

#### VI. ACCEPTANCE AND COMMITMENT FEE

Upon acceptance of the terms herein, the Borrower and the Guarantors shall sign and submit a refundable Commitment Fee of \$10,000 to the Ohio Department of Transportation, Brenna Smathers, 1980 W. Broad Street, 4<sup>th</sup> Floor, Columbus, Ohio 43223. This Commitment Fee can be paid directly to ODOT by the Borrower and/or the Guarantors(s). The Borrower has the right to terminate this agreement prior to the SIB Loan closing. The Commitment Fee will be used to pay advisory fees incurred if the closing process is terminated. This agreement will be terminated by ODOT if not signed and received by December 16, 2022. The SIB Loan is expected to close on or around February 16, 2023.
