## **RESOLUTION 2023-007**

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT TO PURCHASE FOUR (4) FALCON CAMERAS AND ONE (1) FALCON FLEX CAMERA FOR USE BY THE DIVISION OF POLICE THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM

**WHEREAS**, the City of Pataskala Division of Police has a continuing duty to provide efficient and effective service to the residents and businesses of the City as well as the traveling public that passes through the City; and

**WHEREAS**, the City of Pataskala Division of Police wants to use Flock Safety cameras to better protect residents and its police officers and aid investigations; and

**WHEREAS**, the City of Pataskala Division of Police wants the City to purchase, through the Sate of Ohio Competitive Purchasing Program and under a 5-year contract, four (4) mounted Falcon Cameras and one (1) mobile Falcon Flex camera from Flock Safety; and

*WHEREAS*, the total cost of the 5-year contract is Sixty-Six Thousand Four Hundred Dollars and No Cents (\$66,400.00) with the amount due during the 2023 budget year is Fourteen Thousand Four Hundred Dollars and No Cents (\$14,400.00), and the remaining payments for 2024 to 2027 will be Thirteen Thousand Dollars and No Cents (\$13,000.00); and

WHEREAS, the cost for the years 2023, 2024, 2025, 2026, and 2027 has been, or will be, incorporated as part of each year's Capital Improvements Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:

Section 1. Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute an agreement, consistent with Quote 00002545 (through the State of Ohio Competitive Purchasing Program), with Flock Safety to purchase four (4) Falcon Cameras and one (1) Falcon Flex camera, which includes costs for installation, setup, and testing, not to exceed a total of Sixty-Six Thousand Four Hundred Dollars and No Cents (\$66,400.00), with an amount

due in 2023 not to exceed Fourteen Thousand Four Hundred Dollars and No Cents (\$14,400.00), and for subsequent years of Thirteen Thousand Dollars (\$13,000.00).

<u>Section 2</u>: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
