## **RESOLUTION 2023-014**

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT, WITH FLUIDYNE CORPORATION, TO PURCHASE TWO 30 HORSEPOWER BLOWERS FOR THE WATER RECLAMATION FACILITY

**WHEREAS**, the City of Pataskala operates and maintains a Water Reclamation Facility (WRF) at 388 Shawnee Loop South; and

**WHEREAS**, the WRF was upgraded in 2020 to provide better phosphorous removal. However, the upgrade does not provide the requested treatment capabilities because of an error by the design team; and

WHEREAS, the equipment manufacturer believes two additional 30 HP blowers must be added to the Jet Aeration System to provide the previously requested treatment capabilities/results; and

WHEREAS, the design team recently verified the addition of these blowers as the appropriate correction needed for the Jet Aeration System to provide proper wastewater treatment; and

WHEREAS, Council for the City of Pataskala believes the purchase and installation of these blowers is an emergency because they must be installed as soon as possible to provide proper phosphorus removal and meet Ohio EPA regulations; and

WHEREAS, Fluidyne Corporation provided a quote of \$123,950.00 to provide these blowers; and

WHEREAS, the necessary funds are available for these services within the 2023 Utility Budget.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount of One Hundred Twenty-Three Thousand Nine Hundred Fifty Dollars and Zero Cents (\$123,950.00), with Fluidyne Corporation for the purchase of two 30 HP blowers for the WRF.

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
