RESOLUTION 2023-021

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A DESIGN MODIFICATION CONTRACT, WITH AMERICAN STRUCTUREPOINT, INC. TO PERFORM ADDITIONAL ENGINEERING DESIGN FOR THE VINE STREET TRUNK SEWER PROJECT

WHEREAS, the City of Pataskala maintains and improves stormwater systems and related infrastructure within the City; and

WHEREAS, the City of Pataskala has determined it is necessary to make stormwater improvements along Vine Street ("the Vine Street Trunk Sewer Project") in order to mitigate street flooding that occurs within the project area; and

WHEREAS, on June 6, 2022, Council for the City of Pataskala approved Resolution 2022-058 and thereby authorized \$49,500.00 for American Structurepoint, Inc. to design the Vine Street Trunk Sewer Project \; and

WHEREAS, additional drainage and paving, which will enhance the Vine Street Trunk Sewer Project, have been identified as being able to fit within the available construction budget; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to perform this additional work, and to do so, Council for the City of Pataskala needs to execute a design modification in the amount of \$5,800.00, for a new total design contract value of \$55,300.00; and

WHEREAS, funding within the 2023 budget is available for this work.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute a design modification, for a total project amount not to exceed Fifty-Five Thousand Three Hundred Eighty Dollars and No Cents (\$55,300.00), with American Structurepoint, Inc. to complete the engineering design and bidding services for the Vine Street Trunk Sewer Project.

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3:</u> This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
