## **RESOLUTION 2023-023**

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2023 CHEVROLET SILVERADO 3500 HD, FOUR-DOOR, FOUR-WHEEL DRIVE, CREW CAB SERVICE TRUCK FROM COUGHLIN AUTOMOTIVE THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM

**WHEREAS**, the City of Pataskala maintains the public roadways located within the municipality; and

WHEREAS, the City of Pataskala owns and operates service vehicles for the ongoing roadway maintenance; and

**WHEREAS**, the City of Pataskala needs to purchase a new 2023 Chevrolet Silverado 3500 HD, four-door, four-wheel drive, crew cab service truck from Coughlin Automotive ("Service Truck"); and

**WHEREAS**, because the Service Truck will be purchased from Coughlin Automotive, a selected contractor, through the State of Ohio Competitive Purchasing Program, the City of Pataskala does not have to advertise and receive competitive bids; and

**WHEREAS**, the City of Pataskala reasonably estimates the purchase price of the Service Truck will be \$63,830.00; and

**WHEREAS**, the City of Pataskala budgeted for the purchase of this Service Truck as part of its 2023 budget and has the funds available.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract to purchase a 2023 Chevrolet Silverado 3500 HD, four-door, four-wheel drive, crew cab service truck from Coughlin Automotive, for an amount not to exceed

Sixty-Three Thousand Eight Hundred Thirty Dollars and No Cents (\$63,830.00).

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3:</u> This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
