ORDINANCE 2016-4273

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016

WHEREAS, Council previously adopted the Municipal Budget for the year ending December 31, 2016, and is authorized to amend the budget during the budget year; and

WHEREAS, City Council is proceeding to plan for the design and construction of a new Police Station; and

WHEREAS, funding for the project will come from a number of sources, including the Police (208) fund; and

WHEREAS, an interfund transfer from the Police (208) fund to the Capital Facilities (308) fund is being requested in order to provide initial funding for the project; and

WHEREAS, the original operating budget (Ord. 2015-4243), did not include sufficient appropriations from the Police fund for this purpose; and

WHEREAS, the city's soccer and softball programs are provided with referee and umpire services; and

WHEREAS, such referee and umpire services are compensated as independent (IRS 1099) contractors; and

WHEREAS, the original operating budget (Ord. 2015-4243), did not include sufficient appropriations from the Recreation fund for this purpose; and

WHEREAS, the Public Service Director has identified a \$30,000 budget shortfall for appraisal review associated with the Taylor Road Trail project; and

WHEREAS, as the aforementioned project is state-funded, the city is required to provide an independent evaluation of any easement and right of way purchases; and

WHEREAS, the original operating budget (Ord. 2015-4243), did not include sufficient appropriations from the Capital Improvement fund for this purpose; and

WHEREAS, various other budget reclassifications, increases and decreases to the original operating budget have been requested; and

WHEREAS, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2016 budget; and

WHEREAS, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall "make any expenditure of money unless it has been appropriated in such chapter."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:
