RESOLUTION 2015-005

A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A CONTRACT WITH EVOLUTION AG OF UTICA OHIO FOR THE PURCHASE OF 2012 CASE IH 140 TRACTOR LOADER, AN AMOUNT NOT TO EXCEED \$75,000 AND TO WAIVE THE COMPETITIVE BIDDING REQUIREMENT FOR THE PURCHASE.

WHEREAS, the Pataskala Utility Department ("the department") provides environmental treatment services for the residents of Pataskala through the Water Reclamation Facility; and

WHEREAS, the department generates biosolids through the treatment process that requires timely disposal for healthy facility operation and to meet regulatory requirements; and

WHEREAS, the department desires to purchase the necessary equipment to provide economical biosilds disposal methods; and

WHEREAS, the necessary equipment purchase will provide the department the opportunity properly move biosolids at the facility and for land application on facility agricultural fields; and

WHEREAS, the department has identified that the appropriate equipment to be acquired is the 2012 CASE IH Maxxum 140 tractor, and new CASE IH L755 Loader for the sum of seventy five thousand dollars (\$75,000); and

WHEREAS, the state contract vendor, Evolution Ag of Utica has offered to sell the equipment to the city for the sum of seventy five thousand dollars (\$75,000); and

WHEREAS, the cost of the equipment exceeds the current twenty five thousand (\$25,000) bid threshold pursuant to the City's financial policies and procedures, it would therefore require the purchase of the equipment to be competitively bid.

WHEREAS, funding for the purchase of this equipment was included in the 2015 budget.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS CONCURRING THAT:

<u>Section 1:</u> The City Administrator is hereby authorized and directed to execute a purchase order without competitive bidding, in accordance with the duly adopted City of Pataskala Purchasing and Financial Policies, Exception to Competitive Bidding, with Evolution Ag of Utica for the purchase of one (1) 2012 CASE IH Maxxum 140 tractor, and new CASE IH L755 Loader in an amount not to exceed the sum of seventy five thousand dollars (\$75,000).

Section 2: This Resolution shall become effective from and after the earliest period allowed by law.
