**ORDINANCE 2015- 4232**

Passed June 15, 2015

**AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES  
TO THE PATASKALA CODIFIED ORDINANCES.**

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A TWO-THIRDS MAJORITY OF MEMBERS CONCURRING:

SECTION 1: That the ordinances of the City of Pataskala, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2015 Replacement Pages to the Codified Ordinances are hereby approved and adopted.




