Ordinance 2014-4195:

An ordinance authorizing the issuance of not to exceed \$7,225,000 of bonds for the purpose of paying part of the costs of constructing and installing various street improvements in the city, including street improvements related to the Broad Street/State Route 16 Resurfacing Project and the 2013 and 2014 RAMP Program Improvements, and matters related to such bonds.

An ordinance authorizing the issuance of not to exceed \$1,580,000 of bonds for the purpose of paying part of the costs of acquiring and constructing improvements to the City's Water System, and matters related to such bonds.

An ordinance authorizing the issuance of not to exceed \$1,425,000 of bonds for the purpose of paying part of the costs of acquiring and constructing improvements to the City's Sanitary Sewer System, and matters related to such bonds.

Ordinance 2014-4198

An ordinance authorizing the issuance of not to exceed \$190,000 of bonds for the purpose of paying part of the costs of replacing the roof on the City's Police Facility, and matters related to such bonds.

Ordinance 2014-4199

An ordinance consolidating up to four bond issues of the City of Pataskala, Ohio into one or more consolidated bond issues, and establishing the terms of such consolidated bond issues.

An ordinance to amend the mayor's court cost fee schedule of the City of Pataskala.
