### Important Information

**Applicability:** A hot tub permit is required for all hot tubs and spas.

**Hot Tub Regulations:** All hot tubs must meet the following regulations:

- Hot tubs must be located within the side or rear yard.
- Properties with frontage on two (2) streets will be considered to have two (2) front yards.
- Hot tubs must be setback from all property lines a minimum of 10 feet
- Hot tubs must be connect to a ground fault circuit interrupter (GFCI) outlet
- It is the property owner's responsibility to determine property lines and certify the hot tub meets the appropriate setbacks at the time of installation or construction.

**Home Owners Association:**

- It is important to check with the neighborhood Home Owners Association, if applicable, for any hot tub requirements they may have.
- Hot tubs may require approval from the Home Owners Association prior to construction.

**Inspections:**

- The Pataskala Planning and Zoning Department will inspect the hot tub upon completion to ensure that it complies with the approved permit.
