A RESOLUTION TO APPROVE A 'THEN & NOW' CERTIFICATION BY THE CITY FINANCE DIRECTOR PURSUANT TO ORC §5705.41 (D)(2) FOR THE PAYMENT OF OPERATING EXPENDITURES.

WHEREAS, the City's Finance Department received an invoice from the Licking County Development Department for reimbursement of consulting expenses spent on behalf of the Pataskala Joint Economic Development District (JEDD) prior to the issuance date of an approved purchase order; and

WHEREAS, said purchase order involved the expenditure of more than the sum of three thousand dollars (\$3,000.00); and

WHEREAS, Ohio Revised Code (ORC) §5705.41(D)(1) provides, in part, that no subdivision or taxing unit shall "make any contract or give any order involving the expenditure of money unless there is attached thereto a certificate of the fiscal officer of the subdivision that the amount required to meet the obligation or, in the case of a continuing contract to be performed in whole or in part in an ensuing fiscal year, the amount required to meet the obligation in the fiscal year in which the contract is made, has been lawfully appropriated for such purpose and is in the treasury or in process of collection to the credit of an appropriate fund free from any previous encumbrances. This certificate need be signed only by the subdivision's fiscal officer. Every such contract made without such a certificate shall be void, and no warrant shall be issued in payment of any amount due thereon. If no certificate is furnished as required, upon receipt by the taxing authority of the subdivision or taxing unit of a certificate of the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate a sufficient sum appropriated for the purpose of such contract and in the treasury or in process of collection to the credit of an appropriate fund free from any previous encumbrances, such taxing authority may authorize the drawing of a warrant in payment of amounts due upon such contract, but such resolution or ordinance shall be passed within thirty days after the taxing authority receives such certificate; provided that, if the amount involved is less than one hundred dollars in the case of counties or *three thousand dollars* in the case of all other subdivisions or taxing units, the fiscal officer may authorize it to be paid without such affirmation of the taxing authority of the subdivision or taxing unit, if such expenditure is otherwise valid."

COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF THE MEMBERS ELECTED
THERE TO CONCURRING THAT:**


