WHEREAS, the Budget Commission of Licking County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill limitation.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

SECTION 1. The amounts and rates, as determined by the Budget Commission in its certification, are hereby accepted as provided within the attached "Schedule A" and "Schedule B".


SECTION 2. The rate of each tax necessary to be levied within and without the ten mill limitation is hereby levied on the tax duplicate of the City of Pataskala.

SECTION 4. This Resolution shall take effect and be in force at the earliest period allowed by law.

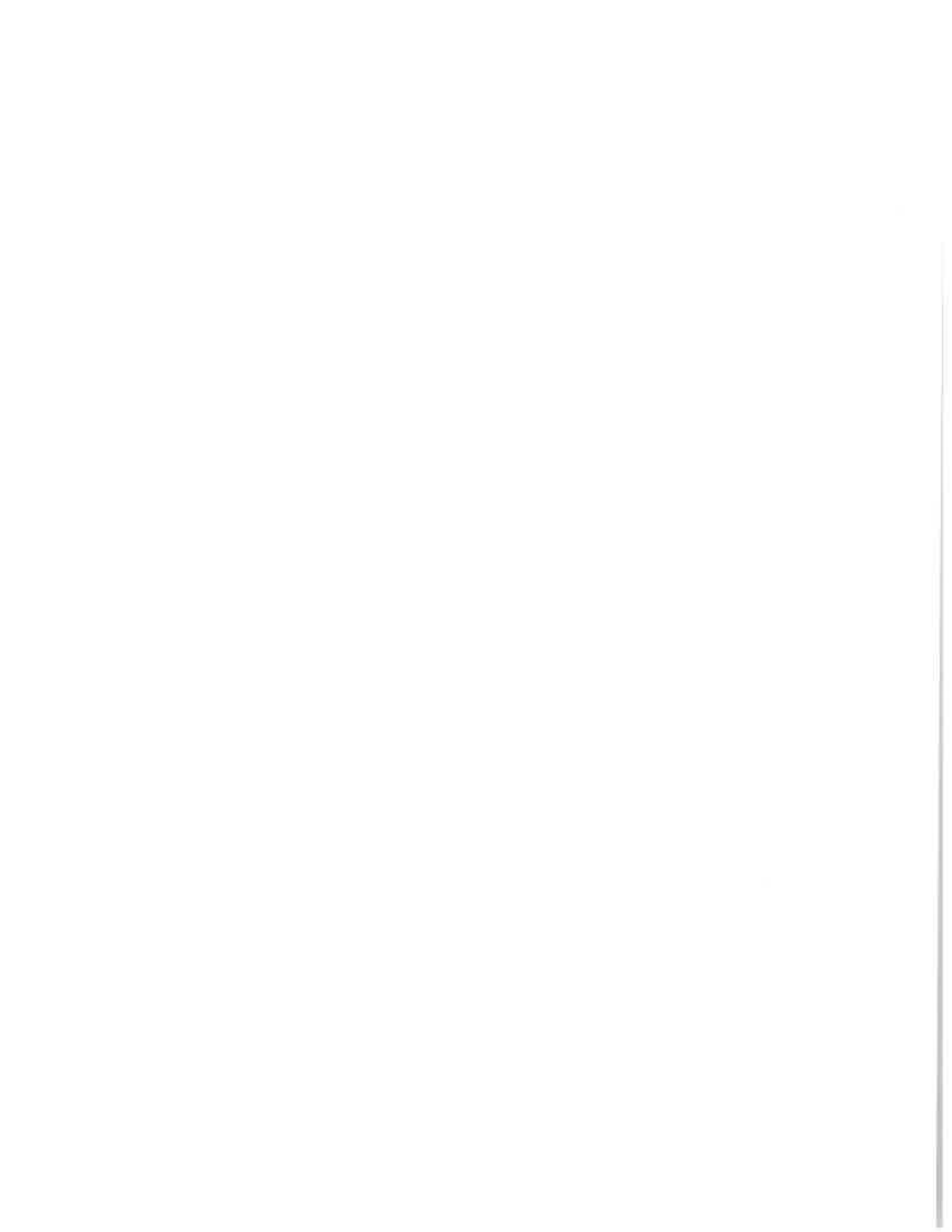

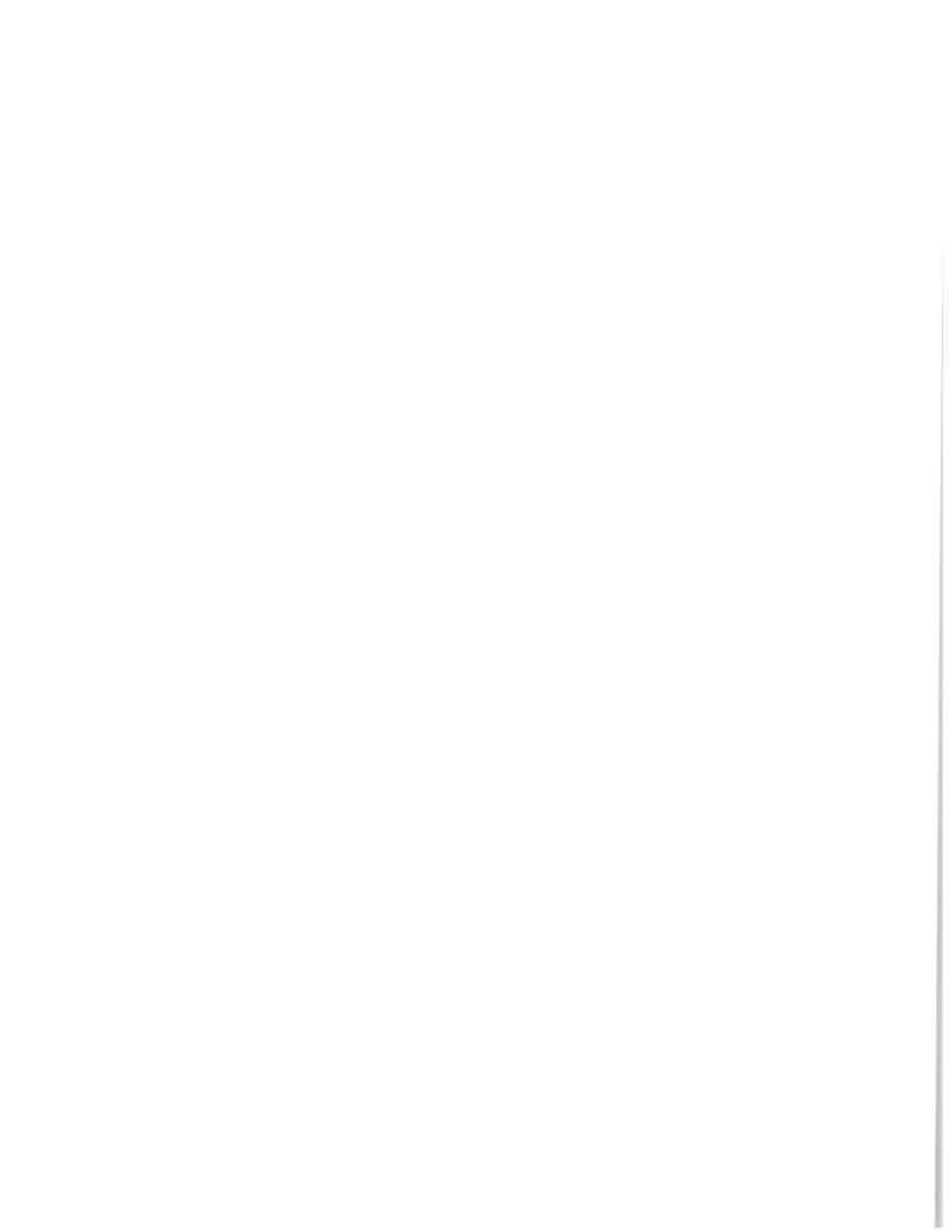
