



## CITY OF PATASKALA

### RESOLUTION 2016-31

Passed March 7, 2016

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ENTER INTO AND EXECUTE A FINAL CONTRACT AND SUBMIT PAYMENT TO THE OHIO DEPARTMENT OF TRANSPORTATION FOR THE LOCAL SHARE OF THE STATE ROUTE 310 PAVING PROJECT.**

The following Final Resolution enacted by the City of Pataskala, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

**WHEREAS**, on 4<sup>th</sup> day of December, 2013, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of resurfacing State Route 310 with curb ramp work, lying within the City of Pataskala; and

**WHEREAS**, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the City limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation, and further, the City agrees to assume and bear one hundred percent (100%) of the cost of the installation and/or repair of curb ramps which are necessary to ensure compliance with the Americans with Disabilities Act.

The share of the cost of the LPA is now estimated in the amount of One Hundred Forty Seven Thousand Seven Hundred Twenty Four dollars, (\$147,724.00), but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

**WHEREAS**, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and

expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

**WHEREAS**, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO; A MAJORITY OF THE MEMBERS PRESENT CONCURRING THAT:**

Section 1: The estimated sum, of One Hundred Forty Seven Thousand Seven Hundred Twenty Four dollars, (\$147,724.00) is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds

Section 2: The LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

Section 3: The LPA enter into a contract with the State, and that the City Administrator be, and is hereby authorized to execute said contract as reflected on the attached Exhibit A, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.


Section 4: The LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

Section 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public and in compliance with all legal requirements of the City of Pataskala, Licking County, Ohio.


Section 6: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
