A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ENTER INTO CONTRACT WITH JOBES HENDERSON & ASSOCIATES FOR THE DESIGN OF THE MILL STREET CULVERT REPLACEMENT PROJECT AND TO SOLICIT COST PROPOSALS FOR CONSTRUCTION OF THE SAME

WHEREAS, the City of Pataskala has a duty to maintain public infrastructure in good condition; and

WHEREAS, the City of Pataskala has determined that a 72" culvert located on Mill Street is deteriorated and in need of replacement ("the Mill Street Culvert Replacement Project"); and

WHEREAS, it is necessary to complete engineering and construction design plans for the Mill Street Culvert Replacement Project, and the City of Pataskala wants to contract with Jobes Henderson & Associates for this service; and

WHEREAS, while the City of Pataskala reasonably estimates the construction cost for the Mill Street Culvert Replacement Project will be less than \$50,000, Council for the City of Pataskala would like Jobes Henderson & Associates to seek estimates (not a formal sealed competitive bidding process) for the construction to make certain the this work will be performed for a reasonable price; and

WHEREAS, the 2017 City of Pataskala budget includes funding for this project.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:


Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed \$13,475, with Jobes Henderson & Associates for the engineering and construction design of the Mill Street Culvert Replacement Project.

Section 2: Council for the City of Pataskala hereby authorizes and directs Jobes Henderson & Associates to solicit cost proposal for construction services of the Mill Street Culvert Replacement Project.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
