



## CITY OF PATASKALA

### RESOLUTION 2017-039

Passed May 15, 2017

**A RESOLUTION REQUESTING THE LICKING COUNTY AUDITOR TO CERTIFY TO THE CITY THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A NEW .75 MILL TAX LEVY FOR PARKS AND RECREATION FUNDING**

**WHEREAS**, with the City of Pataskala, which is a taxing authority, finds that the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for necessary requirements of the political subdivision and that it is necessary to enact a new .75 mill levy, in excess of that limitation, for parks and recreation funding pursuant to ORC 5705.19(H); and

**WHEREAS**, City Council is hereby acting pursuant to ORC 5705.03 to request that the Licking County Auditor to certify certain information to the City in connection with the proposed tax of .75 mill.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** The Licking County Auditor is hereby requested to certify to the City the total current tax valuation of the subdivision (City of Pataskala) and the dollar amount of revenue that would be generated by a .75 mill levy for parks and recreation purposes.

**Section 2:** The proposed levy is a new levy and the purposes of the tax are set forth in ORC 5705.19(H), specifically:

For Parks and Recreation Purposes

**Section 3:** The amount of the proposed levy tax rate is .75 mill and is to be a permanent levy. The levy shall be voted on at the election to be held in November 2017, and the levy shall be a levy upon the duplicate of the then current year (for tax year 2017).


**Section 4:** The Clerk is hereby directed to certify this resolution to the Licking County Auditor.

Section 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 6. This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
