RESOLUTION 2018-022

A RESOLUTION AUTHORIZING THE FINAL AGREEMENT FOR THE TAYLOR ROAD TRAIL PROJECT (ODOT PROJECT ID 96684) AND DIRECTING THE PAYMENT OF THE CITY'S COST SHARE OF \$182,680 TO THE OHIO DEPARTMENT OF TRANSPORTATION.

WHEREAS, on 21st day of October, 2013, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of constructing multi-use paths and sidewalks along Taylor Road and Cleveland Road, lying within the City of Pataskala; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement, less the amount of Federal-Aid Enhancement funds, set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation.

The share of the cost of the LPA is now estimated in the amount of One Hundred Eighty Two Thousand SIX HUNDRED AND EIGHTY and ---- 00/100 Dollars, (\$182,680.00), but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the highway improvement.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS CONCURRING THAT:

Section 1: That the estimated sum, of One Hundred Eighty Two Thousand SIX HUNDRED AND EIGHTY and - - - 00/100 Dollars, (\$182,680.00), is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

Section 2: That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

Section 3: That the LPA enter into a contract with the State, and that City Administrator be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

Section 4: That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.


Section 5: This is to certify that we have compared the foregoing copy of Resolution with the original record thereof, found in the record of the proceeding of the LPA, and which Resolution was duly passed by the LPA on the 16th day of April, 2018, and that the same is true and correct copy of the record of said Resolution and the action of said LPA thereon.

Section 6: We further certify that said Resolution and the action of said LPA thereon is recorded in the journal of said LPA in Resolutions 2018.

Section 7: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 8: This Resolution shall become effective from and after the earliest period allowed by the Charter of the City of Pataskala.
