A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO MAKE AN EMERGENCY PURCHASE AND INSTALLATION OF A BDP INDUSTRIES BELT FILTER PRESS FROM MSD ENVIRONMENTAL SERVICES FOR USE AT THE WATER RECLAMATION FACILITY

WHEREAS, the City's Financial and Purchasing Policy, Article 13, Section 13.01(7)(v) allows the City of Pataskala, under certain circumstances, to make emergency purchases without competitive bidding; and

WHEREAS, R.C. 735.051 also allows, in the case of a real and present emergency arising in connection with the operation and maintenance of the department of public service, including all municipally owned utilities, Council for the City of Pataskala to enter into a contract for work to be done or for the purchase of supplies or materials without formal bidding and advertising; and

WHEREAS, a main component of the water reclamation process is the use of a press to remove liquid sludge from the treatment process; and

WHEREAS, the current water reclamation press unexpectedly stopped working. It is unreliable and unrepairable; and

WHEREAS, by not having a properly working press, the operation and functionality of the water reclamation facility are seriously impacted; and

WHEREAS, given these unforeseen circumstance, the City Administration believes it is necessary to make an emergency purchase of a new press for the water reclamation facility consistent and have it installed immediately; and

WHEREAS, the press will be purchased from, and installed by, MSD Environmental Services in an amount not to exceed \$384,500; and

WHEREAS, the approved 2018 operating budget contains sufficient appropriations for this purchase.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, TWO-THIRDS OF ALL THE MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby determines this situation (the current water reclamation press unexpectedly stopped working) presents a real and present emergency in which the operation of the water reclamation process is seriously impacted.

Section 2: The City Administrator is hereby authorized and directed to make an emergency purchase of a BPD Industries Belt Filer Press from MSD Environmental Services in an amount of \$384,500 without formal bidding and advertising.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

Section 4: This Resolution shall become effective from and after the earliest time allowed by the Charter of the City of Pataskala.
