A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2019 KOBELCO, MODEL SK85 CS-3, MINI TRACK HOE EXCAVATOR AND ACCESSORIES PACKAGE FROM SOUTHEASTERN EQUIPMENT CO., INC., THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM, AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT

WHEREAS, the City of Pataskala maintains public roadways, stormwater systems, and related infrastructure within the City; and

WHEREAS, the City of Pataskala owns and operates equipment for the ongoing maintenance of roadways and stormwater systems; and

WHEREAS, Council for the City of Pataskala understands and recognizes the addition of a new mini track hoe excavator will increase the efficiency and effectiveness of stormwater and roadway installation and maintenance projects; and

WHEREAS, the City of Pataskala wants to purchase a Kobelco, Model SK85 CS-3, Mini Track Hoe Excavator (“Excavator”); and

WHEREAS, because the Excavator will be purchased from Southeastern Equipment Co., Inc., a selected contractor, through the State of Ohio Competitive Purchasing Program, the City of Pataskala does not have to advertise and receive competitive bids; and

WHEREAS, the City of Pataskala reasonably estimates the purchase price of the Excavator will be less than \$110,000; and

WHEREAS, the City of Pataskala budgeted for the purchase of an Excavator as part of its 2019 budget.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute a contract and purchase a 2019 Kobelco, Model SK85 CS-3, Mini Track Hoe Excavator and accessories package from Southeastern Equipment Co., Inc. for an amount not to exceed One Hundred and Ten Thousand Dollars (\$110,000).

Section 2: Council for the City of Pataskala hereby authorizes and directs the City Administrator to enter into a capital lease agreement for the procurement of a 2019 Kobelco, Model SK85 CS-3, Mini Track Hoe Excavator and accessories package.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
