**ORDINANCE 2019-4347**

Passed October 21, 2019

**AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019.**

*WHEREAS*, Council previously adopted the Municipal Budget for the year ending December 31, 2019 (Ord. 2018-4325), and is authorized to amend the budget during the budget year; and

*WHEREAS*, the City has received several donations earmarked for the installation of landscape improvements at the Police station; and

*WHEREAS*, City Council authorized the City to proceed with such landscape improvements in amount not to exceed the sum of eight thousand dollars (\$8,000); and

*WHEREAS*, the remaining outstanding items on Main Street/SR-310 improvements project are the burying of residential electric lines; and

*WHEREAS*, the City estimates that the cost to complete will be the sum of two hundred fifty thousand dollars (\$250,000) and which will exceed the existing purchase order/encumbrance by the sum of one hundred seventy-five thousand dollars (\$175,000); and

*WHEREAS*, the additional funding requirements will be taken from the State Route 310 TIF (306) fund; and

*WHEREAS*, the City's 2018 property tax liabilities (paid in 2019) were approximately eight thousand dollars (\$8,000) more than projected when the 2019 budget was developed; and

*WHEREAS*, an additional appropriation for that amount is requested, as the bills have been paid to the Licking County Treasurer resulting in a deficit position in that budget line; and

*WHEREAS*, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2018 budget; and

*WHEREAS*, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall "make any expenditure of money unless it has been appropriated in such chapter."

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:**

**Section 1:** Council hereby authorizes an increase in the appropriations in the Parks, Lands and Facilities function, Capital Outlay in the amount of **eight thousand dollars (\$8,000.00)** from the **Police Fund (Fund 208)** to pay expenses associated with the installation of landscape improvements, as follows:

**Section 2:** City Council hereby authorizes an increase in the appropriations in the Public Service function, Capital Outlay object in the amount of **one hundred seventy-five thousand dollars (\$175,000.00)** from the **State Route 310 TIF Fund (Fund 306)** to pay expenses associated with the construction of infrastructure improvements along Main Street, as follows:

**Section 3:** City Council hereby authorizes an increase in the appropriations in the Finance function, General Operating Outlay object in the amount of **eight thousand dollars (\$8,000.00)** from the **General Fund (Fund 101)** to pay expenses associated with the payment of property taxes on non-exempt city-owned land, as follows:
