**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH SPENCO EXCAVATING, INC. TO PROCURE MATERIALS FOR THE TOWN STREET TRUNK SEWER PROJECT**

*WHEREAS*, the City of Pataskala maintains and improves stormwater systems and related infrastructure within the City; and

*WHEREAS*, the City of Pataskala determined it is necessary to make stormwater improvements along Town Street and Vine Street (“the Town Street Trunk Sewer Project”) in order to help alleviate yard and basement flooding that occurs within the project area; and

*WHEREAS*, the Town Street Trunk Sewer Project is an emergency project and therefore not included in the 2020 Municipal Budget; and

*WHEREAS*, Council for the City of Pataskala needs the Town Street Trunk Sewer Project to be completed as soon as possible but recognizes that fabrication and delivery time for certain materials (catch basins and manholes) could delay this project; and

*WHEREAS*, Council for the City of Pataskala hopes to prevent this anticipated delay by having SpenCo Excavating, Inc., the contractor for the project, proceed now with ordering/purchasing these materials. The City of Pataskala reasonably estimates the cost will be less than Twenty Thousand Dollars and No Cents (\$20,000.00); and

*WHEREAS*, contemporaneous with this Resolution, Council for the City of Pataskala is reading Supplemental Ordinance 2020-4361, which will provide the necessary funding for the Town Street Trunk Sewer Project, including the cost of these materials.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Twenty Thousand Dollars and No Cents (\$20,000.00), with Spencer Excavating, Inc. to purchase materials for the Town Street

Trunk Sewer project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
