**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH PRIME CONSTRUCTION MANAGEMENT & SURVEY, INC. TO PROVIDE CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES FOR THE TOWN STREET TRUNK SEWER PROJECT**

***WHEREAS***, the City of Pataskala maintains and improves the public roadways and related infrastructure for drainage; and

***WHEREAS***, the City of Pataskala is awarding the Town Street Trunk Sewer Improvement Project construction contract to SpenCo Excavating, Inc.; and

***WHEREAS***, Council for the City of Pataskala wants to make certain the Town Street Trunk Sewer Improvement Project is built per the approved plans and specifications. In order to accomplish this important goal, Council for the City of Pataskala wants to enter into a contract with Prime Construction Management & Survey, Inc. to provide construction administration and inspection services – services the City cannot provide in-house; and

***WHEREAS***, the City of Pataskala reasonably believes these construction administration and inspection services will cost no more than Twenty-Five Thousand Dollars (\$25,000.00). Funding for this contract will be provided from the Street Fund (201).

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Twenty-Five Thousand Dollars and No Cents (\$25,000.00), with Prime Construction Management & Survey, Inc. for construction administration and inspection services for the Town Street Trunk Sewer project.

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

**Section 3:** This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
