**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2020 GMC SIERRA 2500, 4WD, REGULAR CAB, UTILITY BED UTILITY TRUCK FROM BOB ROSS AUTO GROUP THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROCUREMENT PROGRAM**

***WHEREAS***, the City of Pataskala Utility Department is responsible for multiple infrastructure locations throughout the City; and

***WHEREAS***, the City of Pataskala Utility Department maintains a fleet of vehicles that are necessary to operate and maintain said infrastructure; and

***WHEREAS***, the City of Pataskala Utility Department has determined that a 2011 Ford Transit in its fleet is not an acceptable vehicle to use in the operation and maintenance of said infrastructure and will be assigned to office use out of the Department's new location at 430 South Main St; and

***WHEREAS***, the City of Pataskala Utility Department determined a new truck must be added to its fleet in order to perform its daily functions; and

***WHEREAS***, Bobb Ross Auto Group, which participates in the State of Ohio Cooperative Purchasing Procurement Program, provided a quote for a 2020 GMC Sierra 2500, 4WD, Regular Cab, Utility Bed in an amount of Thirty-Four Thousand Five Hundred Sixty-One Dollars and No Cents **(\$34,561.00)**; and

***WHEREAS***, the necessary funds are available for this purchase under the 2020 Utility Budget; and

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract in an amount of Thirty-Four Thousand Five Hundred Sixty-One Dollars and No Cents **(\$34,561.00)**, with Bobb Ross Auto Group for the purchase of a 2020

GMC Sierra 2500, 4WD, Regular Cab, Utility Bed truck.

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


**Section 3:** This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
