A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH SUEZ ADVANCED WATER SOLUTIONS TO CONDUCT THE PATASKALA WATER TOWER MAINTENANCE PROGRAM

WHEREAS, the City of Pataskala owns and maintains multiple water towers; and

WHEREAS, the City of Pataskala recognizes that three of those towers need a maintenance plan; and

WHEREAS, the City of Pataskala Utility Department advertised a request for proposal (RFP) for an all-inclusive water tower maintenance program for those three towers that will cover the next ten years ("Pataskala Water Tower Maintenance Program"); and

WHEREAS, from the proposals submitted, the City of Pataskala Utility Department selected Suez Advanced Water Solutions to conduct the Pataskala Water Tower Maintenance Program; and

WHEREAS, Suez Advanced Water Solutions provided a quote to conduct all aspects of the Pataskala Water Tower Maintenance Program in an amount of One Million Five Hundred Sixty-Four Thousand Eight Hundred Sixty Dollars and No Cents **(\$1,564,860.00)** to be paid in ten annual payments of One Hundred Fifty-Six Thousand Four Hundred Eighty-Six Dollars and No Cents **(\$156,486.00)**; and

WHEREAS, Council for the City of Pataskala believes it is in the City's best interest to fund this program at this time.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract in an amount of One Million Five Hundred Sixty-Four Thousand Eight Hundred Sixty Dollars and No Cents **(\$1,564,860.00)** to be paid in ten annual payments of One Hundred Fifty-Six Thousand Four Hundred Eighty-Six Dollars and No Cents **(\$156,486.00)**, with Suez Advanced Water Solutions to conduct the Pataskala Water Tower

Maintenance Program.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.


