A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE AN INTERAGENCY AGREEMENT WITH THE SOUTHWEST LICKING COMMUNITY WATER AND SEWER DISTRICT

WHEREAS, the Pataskala Corporate Park, which was certified as an Ohio Jobs Ready Site in 2012, is within the boundaries of the Southwest Licking Community Water and Sewer District; and

WHEREAS, the creation of the Corporate Park, in conjunction with the JRS program and a related JRS grant, required certain public improvements to be made in order to serve the future development of the Corporate Park, including but not limited to, the provision of sanitary sewer services; and

WHEREAS, Council for the City of Pataskala and the Board of Trustees of the Southwest Licking Community Water and Sewer District recognize the sanitary sewer service in the Corporate Park is inadequate to service future anticipated development. Additional sewer service improvements are needed to remedy the inadequacy; and

WHEREAS, a financial analysis and funding plan must be created to identify potential revenue mechanisms and sources as well as provide a plan to fund the needed sewer service improvements; and

WHEREAS, Council for the City of Pataskala and the Board of Trustees of the Southwest Licking Community Water and Sewer District want to enter into an Interagency Agreement whereby the District, at its sole expense and selection, will contract for consulting services to create the financial analysis and funding plan. The scope of this analysis will be to identify potential revenue mechanisms and sources as well as provide a plan to fund the needed sewer service improvements in the Corporate Park. Once the analysis has been completed, the City of Pataskala will use its best efforts to cooperate with the District, and other entities as needed, to help enact the recommendations of the analysis. However, the City of Pataskala is not committing, or agreeing to commit, at this time any amount of money to pay for, or help pay for, the analysis and/or the sewer service improvements.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute an Interagency Agreement, in substantially the same form and content as the Agreement attached hereto as Exhibit A and incorporated herein by reference, with the Southwest Licking Community Water and Sewer District.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
