ORDINANCE 2020-4378

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2020.

WHEREAS, Council previously adopted the Municipal Budget (“the budget”) for the year ending December 31, 2020 (Ord. 2019-4353), and is authorized to amend the budget during the budget year; and

WHEREAS, the Families First Coronavirus Response Act (FFCRA) as adopted by the federal government provides funding to states and their political subdivisions to offset costs incurred related to the prevention and remediation of COVID19 impacts in their communities; and

WHEREAS, the city’s FFCRA funding-related appropriations were inadvertently overstated due to pending spending that wasn’t completed until after the supplemental appropriation was approved by Council; and

WHEREAS, the approved 2020 budget must be modified so that the total approved appropriations match the actual funding received by the City; and

WHEREAS, there were a number of budget reductions to the Recreation (206) fund that were identified earlier this year and are now being submitted for approval; and

WHEREAS, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2020 budget; and

WHEREAS, the allocation of income tax revenues to the Debt Service (401) fund was increased during 2020, and which resulted in an insufficient amount of appropriations needed to cover the costs of collection; and

WHEREAS, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall “make any expenditure of money unless it has been appropriated in such chapter.”

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:

Section 1: Council hereby authorizes a reduction in the General Government function, General Operating object in the amount of **twenty-one thousand five hundred dollars (\$21,500.00)** from the Local Coronavirus Relief Fund (Fund 224), as follows:

Section 3: Council hereby authorizes a decrease in the appropriations in the Parks, Lands & Municipal Facilities function, Salary & Related object in the amount of **twenty-eight thousand dollars (\$28,000.00)**; a decrease in the Parks, Lands & Municipal Facilities function, Contractual Services object in the amount of **twenty-six thousand dollars (\$26,000.00)**; and a decrease in the Parks, Lands & Municipal Facilities function, General Operating object in the amount of **one thousand three hundred fifty dollars (\$1,350.00)** in the Local Coronavirus Relief Fund (Fund 224), as follows:

Section 10: Council hereby authorizes an increase in the appropriations in the Police function, Salary & Related object in the amount of **one hundred thousand (\$100,000.00)** in the **Local Coronavirus Relief Fund (Fund 224)**, to pay employee wages and benefits associated with the public safety in order to provide a safe environment for city employees, vendors and residents, as follows:

Section 11: Council hereby authorizes a decrease in the appropriations in the General Government function, Contractual Services object in the amount of **twenty-five thousand dollars (\$25,000.00)** from the **Permissive License Tax Fund (Fund 205)** to reduce approved 2020 spending to reflect actual expenditures to date and to maximize the year-end 2020 carryover balance, as follows:
