



## CITY OF PATASKALA

### COUNCIL MEETING

June 7, 2021

The Council of the City of Pataskala met in regular session on June 7, 2021, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, and Galik-present. Lee joined the meeting already in session. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

#### **Citizens Comments**

#### **Executive Session**

Barstow made a motion to go into Executive Session pursuant to ORC Section 121.22 (G)(1) to consider the compensation of a public employee. Invited into the Executive Session is Mayor Compton and Brian Zets, Law Director, and Jamie Nicholson, Finance Director. Seconded by Carter. Roll Call: Walther, Epperson, Barstow, Hampshire, Galik, and Carter-yes. Lee joined this session already in progress. Mayor Compton declared the motion passed.

Council entered Executive Session at 7:06 PM.

Barstow made a motion to come out of Executive Session. Seconded by Epperson. Roll Call: Epperson, Barstow, Hampshire, Galik, Lee, Carter, and Walther-yes. Mayor Compton declared the motion passed.

Council returned to open session at 7:47 PM.

#### **Discussion and approval of Consent Agenda matters**

Barstow made a motion to approve the Consent Agenda. Seconded by Galik. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, Galik, and Lee-yes. Mayor Compton declared the motion passed.

The Consent Agenda included the Administrator's Report, Department Reports, approval of the May 17, 2021 Council Meeting Minutes and the May 27, 2021, Special Council Meeting Minutes, the adoption of **RESOLUTION 2021-024** and **RESOLUTION 2021-025**, the approval of the **Motion** to excuse the absence of Mrs. Carter from the May 17, 2021 Special

Council Meeting, and the approval of the **Motion** to excuse the absence of Mr. Epperson and Mr. Galik from the May 27, 2021 Special Council Meeting.

### **Reports**

Mayor Compton expressed his appreciation to all that helped with the Memorial Day Celebration and the Farmer's Market.

Todd Barstow addressed upcoming appointments to the Wards and Boundaries Commission. He also announced that he would be stepping down as President of Council as of July 31, 2021.

Tim Hickin, City Administrator announced he would be leaving on vacation this Saturday and was appointing Chris Sharrock as Acting City Administrator. He reported that work continues on Refugee Rd and asked that Ordinance 2021-4393 and Ordinance 2021-4394 be tabled. Mr. Hickin expressed his support for Watkins Memorial Teams' successes at State competitions. He accepted questions from Council.

Jamie Nicholson, Finance Director gave an update on the new Assistant Finance Director that will replace Janice upon her retirement. Mr. Nicholson accepted questions from Council.

Chris Sharrock, Utility Director gave an update on department activities and projects. Mr. Sharrock accepted questions from Council.

Alan Haines, Director of Public Services addressed current projects and department activities. He also requested a Street Committee Meeting be scheduled. Mr. Haines accepted questions from Council.

Scott Fulton, Planning Director addressed the current staffing in his department. Mr. Fulton accepted questions from Council.

Lenier Crawford, Park Manager highlighted various projects and department activities. He accepted questions from Council.

Chief Brooks gave a current staffing update on their Clerks and accepted questions from Council.

**ORDINANCE 2021-4392** Third Reading An ordinance adopting an updated Comprehensive Plan for the City of Pataskala.

Walther made a motion to adopt Ordinance 2021-4392. Seconded by Carter. Roll Call: Walther, Epperson, Barstow, Hampshire, Galik, Lee, and Carter-yes. Mayor Compton declared the motion passed.

Barstow made a motion to table Ordinance 2021-4393. Seconded by Carter. Roll Call: Epperson, Barstow, Hampshire, Galik, Lee, Carter, and Walther-yes. Mayor Compton declared the motion passed.

Barstow made a motion to table Ordinance 2021-4394. Seconded by Carter. Roll Call: Barstow, Hampshire, Galik, Lee, Carter, Walther, and Epperson-yes. Mayor Compton declared the motion passed.

Barstow made a motion to have the first reading of Ordinance 2021-4395. Seconded by Carter. The Clerk read the following:
