ORDINANCE 2021-4395

Passed July 6, 2021

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021.

WHEREAS, Council previously adopted the Municipal Budget ("the budget") for the year ending December 31, 2021 (Ord. 2020-4375), and is authorized to amend the budget during the budget year; and

WHEREAS, the construction of the Pataskala Police facility is complete and there remains approximately forty-two thousand thirty dollars (\$42,030) in the Bond Improvements (302) fund; and

WHEREAS, Ohio Revised Code §5705.14(A) states that "The unexpended balance in a bond fund that is no longer needed for the purpose for which such fund was created shall be transferred to the sinking fund or bond retirement fund from which such bonds are payable."; and

WHEREAS, the Finance Director is requesting authorization to transfer the aforementioned balance to the Debt Service (401) fund; and

WHEREAS, the Police department recently had independent fiber internet connectivity installed at the Police station; and

WHEREAS, the additional \$700 per month in operating costs were not included in the 2021 budget; and

WHEREAS, the City's Finance Manager will be retiring from the City effective August 6, 2021 and upon her separation from employment after 26 years of service with the City, she will be paid out for all accrued leave balances she's entitled to pursuant to the City's Employee Handbook; and

WHEREAS, the total cost of the paid leave is estimated to be the approximately twenty-four thousand dollars (\$24,000), the sum of which was not included in the 2021 budget; and

WHEREAS, various other budget reclassifications, increases and decreases to the original operating budget have been requested; and

WHEREAS, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2021 budget; and

WHEREAS, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall "make any expenditure of money unless it has been appropriated in such chapter."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:

Section 1: Council hereby authorizes an increase in the appropriations in the Transfers & Advances function, Transfers & Advances object in the amount of **forty-two thousand thirty dollars** (\$42,030.00)

from the **Bond Improvements Fund (Fund 302)** to transfer the unexpended balance from the Police Station project pursuant to ORC 5705.14(A), as follows:

Section 2: Council hereby approves the interfund transfer identified in Section 1 above and directs the Finance Director to effect such transfer.

Section 3: Council hereby authorizes an increase in the appropriations in the Police function, General Operating object in the amount of six thousand three hundred dollars (\$6,300.00) from the Police Fund (Fund 208) to pay expenses associated with operating a fiber data connection to the Police station, as follows:
