## **RESOLUTION 2022-031**

## Failed March 21, 2022

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2022 JOHN DEERE 6110M CAB TRACTOR, A JOHN DEERE FC10R FLEX WING ROTARY CUTTER PULL BEHIND MOWER DECK, AND AN ALAMO RM 165 60' ROTARY HEAD ARM MOWER ATTACHMENT FROM AG-PRO COMPANIES THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT

*WHEREAS*, the City of Pataskala maintains and mows City-owned property, public spaces, and road right-of-way within the City; and

*WHEREAS*, in order to complete its mowing responsibilities, the City of Pataskala owns and operates mowing equipment; and

**WHEREAS**, Council for the City of Pataskala understands and recognizes the need to replace the City's existing tractor, arm mower, and mower deck because this equipment is approaching the end of useful life and new mowing equipment will help the City complete its mowing responsibilities more efficiently and effectively; and

*WHEREAS*, to help finance this purchase, the City of Pataskala intends to trade the Case IH 115 Cab Tractor, which has a value of \$48,000; and

*WHEREAS*, the City of Pataskala wants to purchase a 2022 John Deere 6110M Cab Tractor, a John Deere FC10R Flex Wing rotary cutter pull behind mower deck, and an Alamo RM 165 60' rotary head arm mower attachment; and

*WHEREAS*, the City of Pataskala reasonably estimates the purchase price of the Tractor and Mower Attachments, after trade in, will be \$80,110.40; and

*WHEREAS*, the City of Pataskala budgeted for the purchase of a Tractor and Mower Attachments as part of its 2022 budget as CIP project SVC-20-005.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT: <u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to enter into a capital lease agreement for the procurement of a 2022 John Deere 6110M Cab Tractor, a John Deere FC10R Flex Wing rotary cutter pull behind mower deck, and an Alamo RM 165 60' rotary head arm mower attachment.

<u>Section 2:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract to purchase a 2022 John Deere 6110M Cab Tractor, a John Deere FC10R Flex Wing rotary cutter pull behind mower deck, and an Alamo RM 165 60' rotary head arm mower attachment from Ag-Pro Companies, through the State of Ohio Competitive Purchasing Program, with Ago-Pro Companies, for an amount not to exceed Eighty Thousand, One Hundred Ten Dollars and Forty Cents (\$80,110.40), including the trade in of the City's Case IH 115 Cab Tractor.

<u>Section 3:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
