**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A RENEWAL CONTRACT WITH AGRI-SLUDGE INC. FOR THE BIOSOLIDS PROGRAM**

*WHEREAS*, the City of Pataskala Utility Department generates Class B biosolids as a byproduct to the wastewater treatment process; and

*WHEREAS*, the Class B biosolids must be land-applied to approved fields or disposed of in approved landfills in accordance with Ohio EPA regulations; and

*WHEREAS*, with Resolution 2019-022, adopted on March 4, 2019, Council for the City of Pataskala authorized a contract with Agri-Sludge, Inc. for land application or landfill disposal. The 2019 contract is about to end. However, pursuant to the express terms of the 2019 contract, it may be renewed for three consecutive one-year terms (“Renewal Terms”) upon agreement of the Parties; and

*WHEREAS*, Agri-Sludge Inc. provided a quote for land application in the amount of **\$30.00** per wet ton and for landfill disposal in the amount of **\$60.00** per wet ton, with a total cost not to exceed **\$25,500.00**. This is a price increase of approximately six percent; and

*WHEREAS*, the funds needed to meet this expenditure are available in the Utility Budget; and

*WHEREAS*, Council for the City of Pataskala believes it is in the City’s best interest to retain Agri-Sludge Inc. to perform this biosolid land application work.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a renewal contract, with a term of two years, in an amount not to exceed Twenty-Five Thousand Five Hundred Dollars and No Cents (**\$25,500.00**) with Agri-Sludge Inc. for the Biosolids Program

Section 2: It is hereby found and determined that all formal actions of this Council concerning

and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
