# **COUNCIL MEETING**

April 4, 2022

The Council of the City of Pataskala met in regular session on April 4, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, Galik, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

## Discussion and approval of Consent Agenda matters

Walther asked that Resolution 2022-040 be removed from the Consent Agenda.

Epperson made a motion to approve the Consent Agenda. Seconded by Walther. Roll Call: Carter Walther, Epperson, Barstow, Hampshire, Galik, and Lee-yes. Mayor Compton declared the motion passed.

The Consent Agenda included the Administrator's Report, Department Reports, approval of the March 21, 2022 Council Meeting Minutes, Motion to excuse the absence of Tom Lee from the March 21, 2022 Council Meeting, and the approval of **RESOLUTION 2022-038** and **RESOLUTION 2022-039**.

Walther made a motion to have the third reading of Ordinance 2022-4415 as amended. Seconded by Galik. The Clerk read the following:

**ORDINANCE 2022-4415** <u>Third Reading</u> An ordinance to make supplemental appropriations for current expenses and other expenditures during the fiscal year ending December 31, 2022.

Lee made a motion to adopt Ordinance 2022-4415 as amended. Seconded by Walther. Roll Call: Epperson-yes, Barstow-no, Hampshire-yes, Galik-yes, Lee-yes, Carter-yes, and Walther-yes. Mayor Compton declared the motion passed.

Walther made a motion to have the third reading of Ordinance 2022-4416. Seconded by Galik. The Clerk read the following:

**ORDINANCE 2022-4416** <u>Third Reading</u> An ordinance creating and establishing 2 new positions within the City of Pataskala Parks and Recreation Department, to wit: Concession Stand Worker and Concessions Assistant Manager.

Walther made a motion to adopt Ordinance 2022-4416. Seconded by Lee. Toll Call: Hampshire-yes, Galik-yes, Lee-yes, Carter-yes, Walther-yes, Epperson-yes and Barstow-no. Mayor Compton declared the motion passed.

Walther made a motion to have the second reading of Ordinance 2022-4418. Seconded by Galik. The Clerk read the following:

**ORDINANCE 2022-4418** Second Reading An ordinance amending section 929.08 of the Codified Ordinances of the City of Pataskala (Water Service Rates) and thereby creating and establishing a Bulk Water Point Rate.

## New Business

Carter made a motion to have the first reading of Ordinance 2022-4419. Seconded by Galik. The Clerk read the following:

**ORDINANCE 2022-4419** First Reading An ordinance creating and establishing a new position within the City of Pataskala Parks and Recreation Department, to wit: Parks Maintenance Coordinator

Discussion of Ordinance 2022-4420 was regarding the total cost, the scope, and the proposals.

**ORDINANCE 2022-4420** First Reading An ordinance creating and establishing a new position within the City of Pataskala Public Service Department, to wit: Assistant City Engineer.

Discussion of Resolution 2022-040 was regarding the proposals.

Lee made a motion to adopt **RESOLUTION 2022-040**, a resolution authorizing and directing the City Administrator to execute a contract with Prime Construction Management & Survey, Inc. To provide construction administration and inspection services for the Taylor Road Storm Sewer Improvement Project. Seconded by Carter. Roll Call: Walther, Epperson, Barstow, Hampshire, Galik, Lee, and Carter-yes. Mayor Compton declared the motion passed.

Epperson made a motion to approve the sign project. Seconded by Walther. Roll Call: Barstow, Hampshire, Galik, Lee, Carter, and Walther. Mayor Compton declared the motion passed.

Galik made a motion to approve the Agricultural Ad District as submitted by Douglas, James Beeson. Seconded by Walther. Roll Call: Barstow, Hampshire, Galik, Lee, Carter, Walther, and Epperson. Mayor Compton declared the motion passed.
