### RESOLUTION 2022-046

#### **A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH LAW GENERAL CONTRACTING INC. FOR CONSTRUCTION SERVICES FOR THE TWO-INCH WATERLINE UPGRADE PROJECT**

*WHEREAS*, as required by Section 8.02 of the Charter, the City of Pataskala advertised and received bids, via Resolution 2022-028, for the Two-Inch Waterline Upgrade Project; and

*WHEREAS*, the bid opening for this project was held on Wednesday, April 6, 2022; and

*WHEREAS*, the lowest and best bid for the work was submitted by Law General Contracting Inc. in the amount of **\$360,694.88**, which is within the awardable threshold of 10% of the engineer's estimate; and

*WHEREAS*, because this project involves digging in Old Town, the Utility Director would like Council to authorize about \$40,000.00 above the bid amount for any contingency items. The funds for this project are identified in the 2022 Budget; and

*WHEREAS*, Council of the City of Pataskala hereby recognizes the need to enter into an agreement with the lowest and best bidder and believes Law General Contracting Inc.'s bid meets this requirement.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to accept the bid of, and execute a contract with, Law General Contracting Inc. for construction services of the Jefferson Street Waterline Project, with the total project amount not to exceed Four Hundred Thousand Dollars and No Cents (**\$400,000.00**).

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that

all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
