A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2022 JOHN DEERE 5100E CAB TRACTOR AND JOHN DEERE R10 FLEX WING ROTARY CUTTER PULL BEHIND MOWER DECK FROM AGPRO COMPANIES THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT

WHEREAS, the City of Pataskala maintains and mows City-owned property, public spaces, and road right-of-way within the City; and

WHEREAS, in order to complete its mowing and maintenance responsibilities, the City of Pataskala owns and operates mowing equipment; and

WHEREAS, Council for the City of Pataskala understands and recognizes the need to add a tractor and mower deck to the fleet to help the City complete its mowing responsibilities, and other tasks, more efficiently and effectively; and

WHEREAS, the City of Pataskala wants to purchase a 2022 John Deere 5100E Cab Tractor and a John Deere R10 Flex Wing rotary cutter pull behind mower deck; and

WHEREAS, the City of Pataskala reasonably estimates the purchase price of the Tractor and Mower Deck, will be \$75,767.31. However, competitive bidding is not required because the City of Pataskala can purchase this equipment under a State of Ohio Procurement Contract; and

WHEREAS, the City of Pataskala budgeted for the purchase of a Tractor and Mower Deck as part of its 2022 budget as CIP project SVC-20-005.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to enter into a capital lease agreement for the purchase of a 2022 John Deere 5100E Cab Tractor and a John Deere R10 Flex Wing rotary cutter pull behind mower deck.

Section 2: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute a contract to purchase a 2022 John Deere 5100E Cab Tractor and a John Deere R10 Flex Wing rotary cutter pull behind mower deck from Ag-Pro Companies, through the State of Ohio Competitive Purchasing Program, for an amount not to exceed Seventy-Five Thousand Seven Hundred Sixty-Seven Dollars and Thirty-One Cents (\$75,767.31).

<u>Section 3:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
