## CITY OF PATASKALA

### RESOLUTION 2022-056

#### **A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT THE BID OF, AND EXECUTE A CONTRACT WITH, THE SHELLY COMPANY FOR CONSTRUCTION SERVICES FOR THE 2022 ROADWAY IMPROVEMENTS PROGRAM**

*WHEREAS*, as required by Section 8.02 of the Charter, the City of Pataskala advertised and received bids, via Resolution 2022-043, for the 2022 Roadway Improvements Project; and

*WHEREAS*, the bid opening for this project was held on Thursday, May 12, 2022; and

*WHEREAS*, the lowest and best bid for the Base Bid work, including improvements to Graham Road, Refugee Road, Summit Road, Haystack Avenue, Hayloft Court, Straw Court, and a parking lot in Foundation Park, was submitted by The Shelly Company in the amount of \$737,217.95, which is within the awardable threshold of 10% of the engineer's estimate; and

*WHEREAS*, Council of the City of Pataskala hereby recognize the need to enter into an agreement with the lowest and best bidder and believes The Shelly Company's bid meets this requirement; and

*WHEREAS*, in addition to the Base Bid work, the City of Pataskala wants to complete Bid Alternate #2 at this time, and make improvements to Havens Corners Road in the amount of \$48,515.82; and

*WHEREAS*, Council of the City of Pataskala recognizes the value of including contingency funding to cover miscellaneous unplanned items during construction, and hereby authorizes a total value of \$835,000 for the project.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: The City Administrator is hereby authorized to accept the bid of, and execute a contract with, The Shelly Company for the 2022 Roadway Improvements Project with the total project amount not to exceed \$835,000.00 for the Base Bid and Bid Alternate #2.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that

all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall become effective from and after the earliest period allowed by the Charter of the City of Pataskala.
