COUNCIL MEETING

July 5, 2022

The Council of the City of Pataskala met in regular session on July 5, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, Galik, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Citizens Comments

There were no comments.

Executive Session

Lee made a motion to go into Executive Session pursuant to R.C. 121.22(G)(1), to consider compensation of a public employee. Invited into the executive session will be Tim Hickin, City Administrator, Mayor Compton, and Brian Zets, Law Director. Seconded by Barstow. Roll Call: Walther, Epperson, Barstow, Hampshire, Galik, Lee, and Carter-yes. Mayor Compton declared the motion passed.

ORDINANCE 2022-4421 Third Reading An ordinance to rezone properties located at 12520 Refugee Road SW (Parcel No. 063-140394-00.000), 12510 Refugee Road SW (Parcel No. 063-140394-01.000), and 12490 Refugee Road SW (Parcel No. 063-140394-02.000), totaling 38.32 +/acres in the City of Pataskala, from the Medium-Low Density Residential (R-87) zoning classification to the Planned Manufacturing (PM) zoning classification.

Walther made a motion to adopt Ordinance 2022-4421. Seconded by Lee. Roll Call: Hampshireyes, Galik-yes, Lee-yes, Carter-yes, Walther-yes, Epperson-yes, and Barstow-no. Mayor Compton declared the motion passed.
