# A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.

*WHEREAS*, the Budget Commission of Licking County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten-mill limitation.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:

<u>Section 1:</u> The amounts and rates, as determined by the Budget Commission in its certification, are hereby accepted as provided within the attached "Schedule A" and "Schedule B"

<u>Section 2:</u> The rate of each tax necessary to be levied within and without the ten-mill limitation is hereby levied on the tax duplicate of the City of Pataskala.

<u>Section 3:</u> The Clerk of Council is hereby directed to certify a copy of this Resolution to the Auditor of Licking County, Ohio.

<u>Section 4:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 5: This Resolution shall become effective from and after the earliest period allowed by the Charter of the City of Pataskala.
