March 6, 2023

The Council of the City of Pataskala met in regular session on March 6, 2023 at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Hite, Walther, Epperson, Dandurand, Hampshire, Galik, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Executive Session

Walther made a motion to go into Executive Session pursuant to R.C.
