## **RESOLUTION 2023-033**

## A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ACCEPT THE BID OF, AND EXECUTE AN AGREEMENT WITH, AXIS CIVIL CONSTRUCTION FOR CONSTRUCTION SERVICES FOR THE CABLE ROAD BRIDGE REPLACEMENT PROJECT

*WHEREAS*, as required by Section 8.02 of the Charter, the City of Pataskala advertised and received bids, via Resolution 2022-095, for the Cable Road Bridge Replacement Project; and

WHEREAS, the bid opening for this project was held on Thursday, April 6, 2023; and

*WHEREAS*, the lowest and best bid was submitted by Axis Civil Construction in the amount of \$423,506.00, which is within the awardable threshold of 10% of the engineer's estimate; and

*WHEREAS*, Council of the City of Pataskala recognizes the need to enter into an agreement with the lowest and best bidder and believes Axis Civil Construction's bid meets this requirement; and

**WHEREAS**, Council of the City of Pataskala recognizes the value of including contingency funding to cover miscellaneous unplanned items during construction, and hereby authorizes a total value of \$455,000 for the project; and

*WHEREAS*, the funding for this work was previously encumbered as part of the 2020, 2021, and 2022 budgets, in anticipation of this project.

## NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to accept the bid of and execute an agreement, in an amount not to exceed Four Hundred Fifty-Five Thousand Dollars and No Cents (\$455,000.00), with Axis Civil Construction to perform construction services for the Cable Road Bridge Improvements Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning

and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
