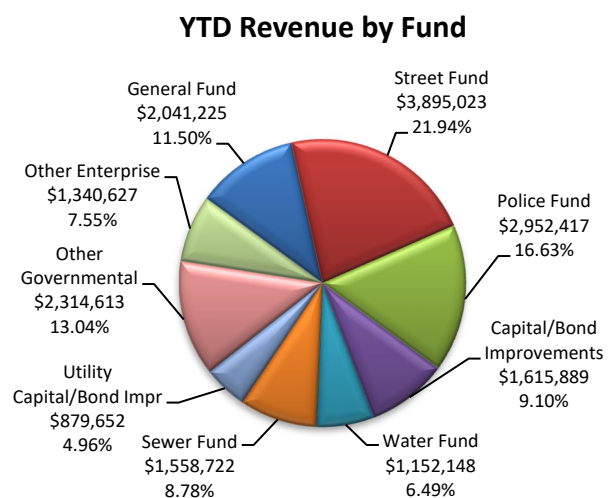
RE: August 2023 Financial Condition Report

The Finance department continued to be busy and productive during the month of August as we accomplished the following: (1) printed and mailed the 2022 Popular Annual Financial Report (PAFR) to all city residents; (2) completed the development of the 2024-2028 budgets for the Finance, Debt Service and other citywide functions; (3) prepared the 2024-2028 revenue forecast for the budget process; (4) calculated and paid retroactive pay increases to all non-union employees; (5) completed the interview process to identify a replacement for the open Assistant Finance Director position; and (6) completed the onboarding process for several new employees.

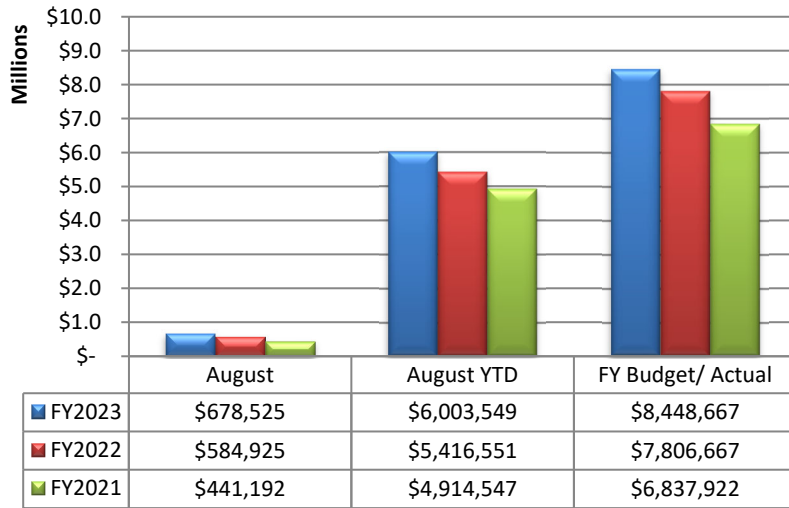
I anticipate that the month of September will also be a very busy month. In addition to providing routine payroll and accounts payable services, we will continue to focus much of our efforts on the 2024 budget process. In addition, we also plan to: (1) compile the departmental budget submissions to determine overall financial condition; (2) update the 2024-2028 revenue forecast for the budget process to ensure that any grant or loan revenue is included; (3) finalize the 2024 budget submissions and begin creation of the budget workshop document; (4) continue to work with the other members of the COHCC Board on the development and approval of the 2024 medical insurance renewal rates; (5) complete the hiring/onboarding process for the new Assistant Finance Director; and (6) identify investment strategies to manage the city's investment portfolio in an low but rising interest rate environment.

REVENUE/RECEIPTS

I am pleased to present this report on the financial condition of the city as of August 31, 2023. On a year-to-date (YTD) cash basis, the city has collected approximately \$17.75 million in total revenue from all sources, or 43.49% of the full-year budget. This total is somewhat misstated, however, due to: (1) \$1.80 million in interfund transfers that were made in February; (2) property tax/TIF PILOT revenues of \$1.80 million received; (3) \$502.9 thousand in grant funding not yet received; and (4) \$16.93 million in debt issuances that haven't yet occurred. Excluding those items would result in a YTD collections rate that is equal to 71.44% of budget, somewhat above budget but much closer to the straight-line rate of 66.67%.



Income Tax Collections - All Funds



Income tax collections for the month of August were \$678.5 thousand (equal to 8.03% of budget) and were \$93.6 thousand (16.0%) higher than last year when compared to August 2022. Total year to-date collections are \$6.0 million (71.06% of budget) and, when compared to an August 2022 YTD total of \$5.42 million, are \$587.0 thousand (10.84%) higher. The full-year budget is currently projected to be \$8.45 million, an increase of \$642.0 thousand, or 8.22% over FY 2022 collections. It is important to note that the August 2022 YTD collections were

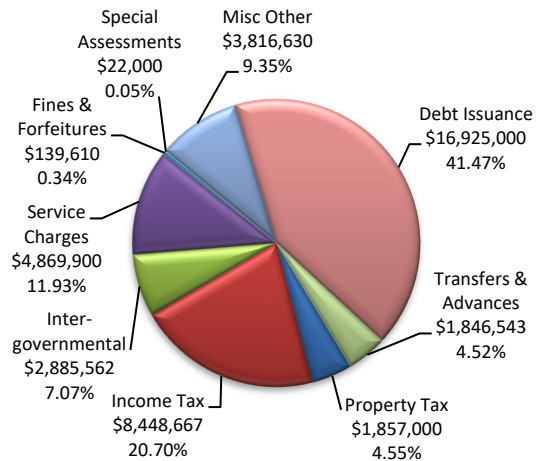
equal to 69.38% of the full-year 2022 collections, and in 2021, the rate was equal to 71.87% of FY 2021 collections. During the month of August, we increased the revenue forecast by \$442.6 thousand (5.53%) to reflect the increased rate of collections through July.

The city received its second-half 2022 property tax settlement from Licking County in the month of August. The 2023 budget in this line is \$1.86 million (4.55% of the total budget) and is projected to be up by \$150.0 thousand (8.79%) from FY 2022 receipts. Total property taxes received to-date are \$1.80 million and are \$161.8 thousand (9.86%) higher than the same period in 2022.

Intergovernmental revenues represent one of the other more significant revenue categories for the city. They reflect funding received by the city from the federal, state and county governments. The revenues can come in the form of loans, grants or reimbursements. For 2023, a total of \$2.89 million is budgeted, with \$916.7 thousand of the total expected to come from grants and loans. Through August 31, approximately \$1.70 million has been collected (59.0% of the category budget) and is down by \$622.1 thousand (26.76%) from 2022. This is the result of reduced one-time grant and loan receipts in 2023.

Service charge revenues are another major revenue category for the city. As the title would imply, these revenues are received in exchange for providing services to residents, businesses and other customers. For 2023, approximately \$4.87 million is budgeted for total service charge revenues. Year to-date collections are \$3.55 million, or 72.95% of budget. The eight-month total is down by \$21.2 thousand (0.59%) when compared to 2022. At \$4.42 million or 90.74% of the category budget, water and sewer usage fees represent the largest single component of this category. Usage fees collected through August 31 are \$3.21 million, or 72.73% of the full-year budget in this line item.

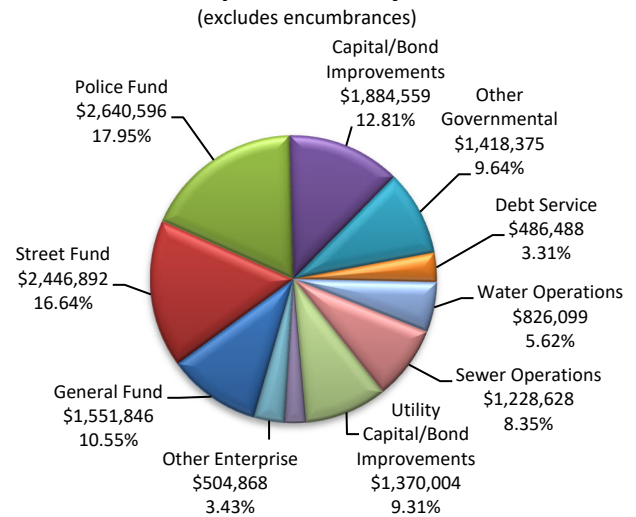
All Funds Revenue - Budget



EXPENDITURES/SPENDING

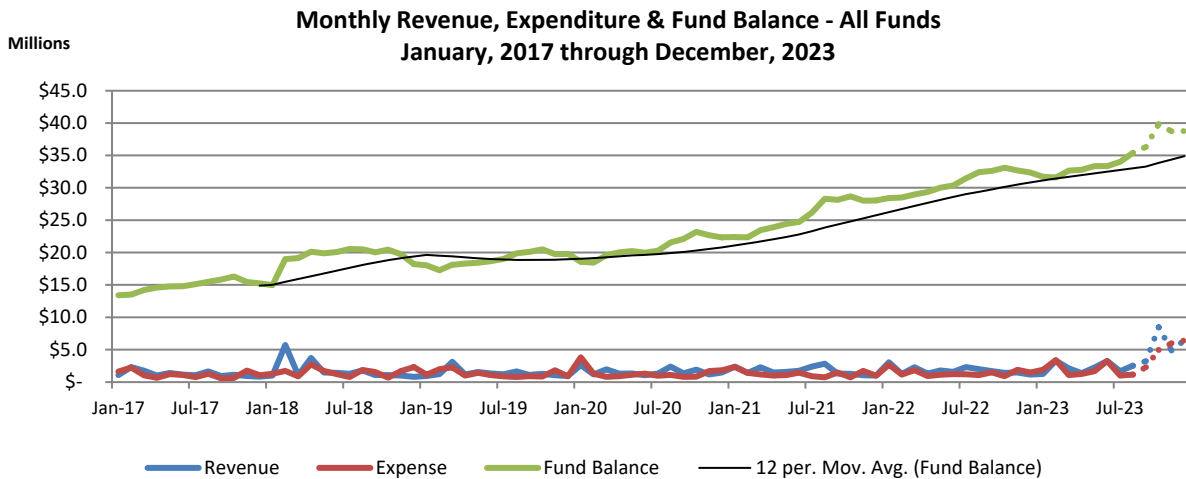
As we continue through the third-quarter of 2023, spending trends appear to be in-line with expectations. Excluding debt service expenses and interfund transfers in the calculation results in a spending rate equal to 40.0%, well below the straight-line rate of 66.67%. The lower than anticipated spending was the result of below-budget spending on contractual services, capital outlay and wage and related expenses. Including 2022 carryover encumbrances (e.g., purchase orders) as well as FY 2023-issued POs in the total results in a ratio of 60.19%. Many of these 2023 purchase orders encumber full-year spending and have the effect of overstating the impact of the encumbrances.

FUND BALANCE/FINANCIAL HEALTH

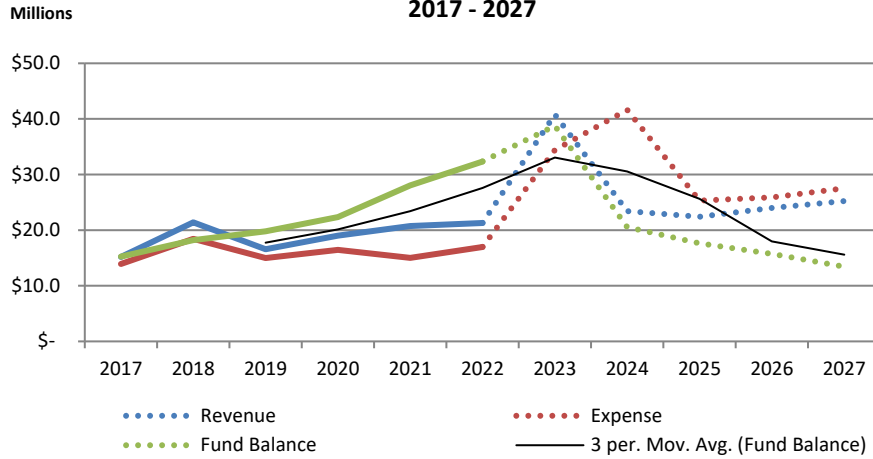
The chart below plots revenue, expenditures, and fund balance since January 2017. The solid color lines represent actual numbers and any dotted lines reflecting the current forecast. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over the time horizon of the chart.



Current projections call for the total all-funds balance to increase by \$6.37 million in 2023 (see chart at the top of the following page which has been updated to reflect the current 5-year forecast) to a total funds balance of about \$38.76 million. The year-end 2022 total fund balance was \$32.37 million, an increase of \$7.43 million (29.81%) over the budget which resulted from below-budget spending in 2022 (down \$9.07 million) and revenue that was \$1.67 million (7.28%) below budget. From 2024 – 2027, however, the balance will decline every year during that period of time. This is due to expenditures either exceeding or being roughly equal to revenues in each of those succeeding years.

The General fund ended the month of August 2023 with an unencumbered balance of \$3.70 million and is up by \$295.5, or 8.69% from December 2022. The Street (201) fund is up by \$1.08 million (27.49%), and the Police (208) fund decreased by \$47.7 thousand (1.22%). The 2023 forecast calls for these funds to end the

year approximately 15-35% below where they ended 2022. As we move forward through 2023, it is critical for the city to continue to closely monitor each of the key fund balances to ensure that adequate funding is available to provide the desired level of service to the community in the future. Maintaining adequate reserves to ensure ongoing operations and the ability to service our debt are just

some of the factors that the ratings agencies consider when evaluating the city’s overall fiscal health, and it’s a ‘best practice’ in the public finance profession. We will also be working to reduce and manage the spending side of the equation to minimize the need to draw from existing reserves.

I am providing this summary analysis to facilitate a better understanding of the sources of all city revenues, the status of collections to-date and available fund balances. The report will now turn its focus to each of the primary governmental and enterprise funds of the city: 101 – General Fund; 201 – Street Fund; 208 – Police Fund; 301 – Capital Improvements; and 601/651 – Water and Sewer Operations funds.

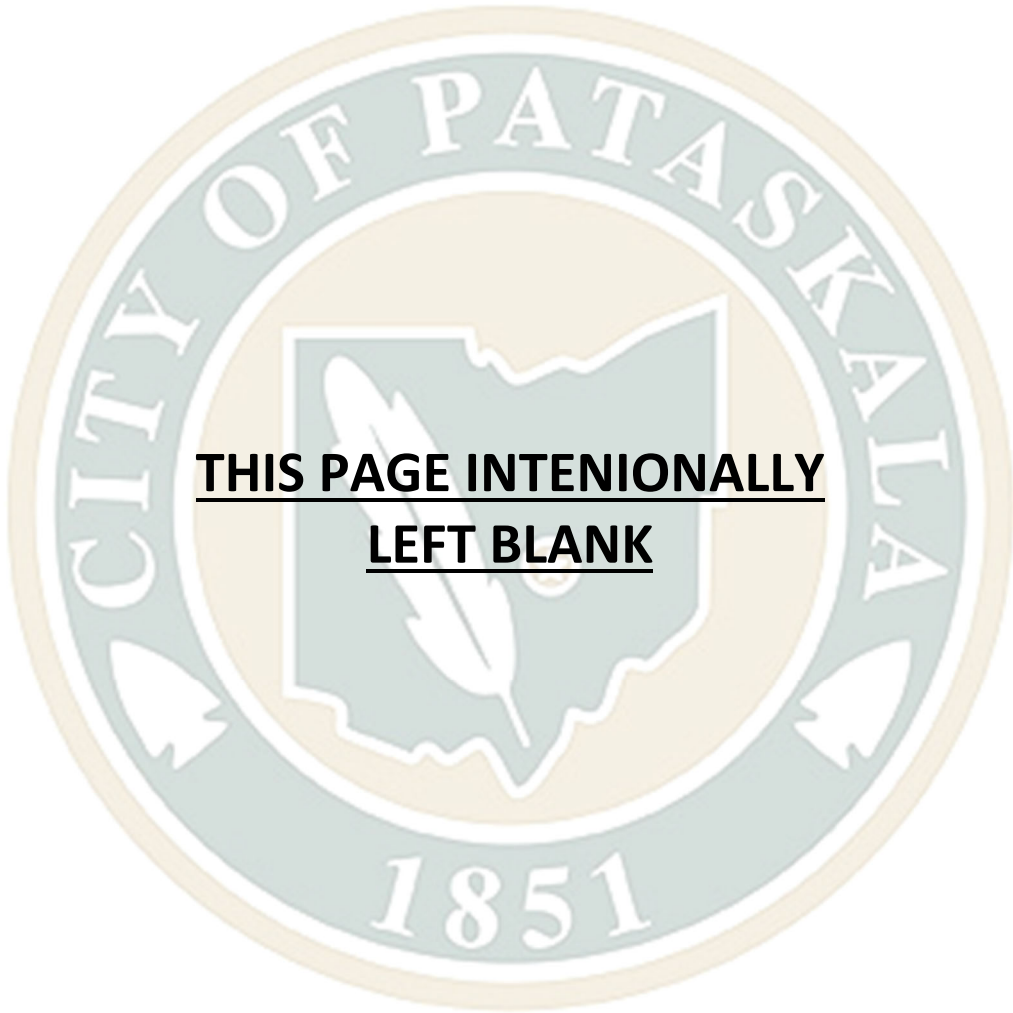

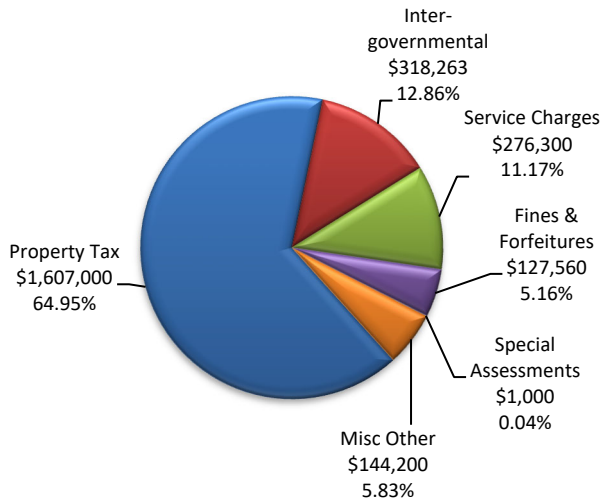

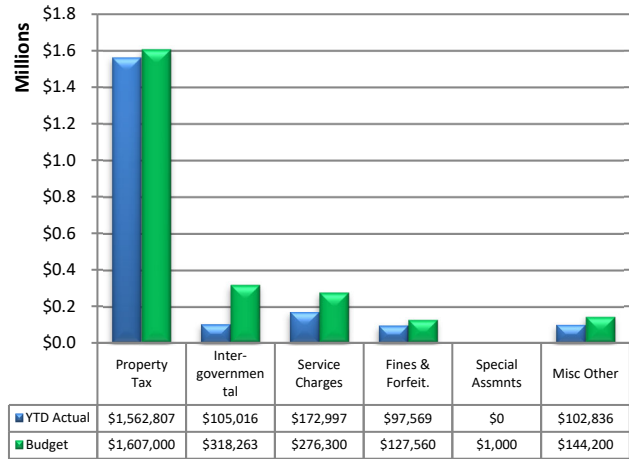
General Fund (101)

Revenue – On a year to-date-year basis, the general fund has been credited with total revenue of approximately \$2.04 million, which represents 82.50% of budget. When compared to a straight-line rate of 66.67%, it is clear that general fund revenues through August 31st are running well ahead of budget. The timing of when the city receives its semi-annual property tax settlements, however, does skew the total. We received the 2nd half property tax settlement during the month of August. Eliminating the impact that the timing of the property tax receipts has in the calculation, the total is running at 61.44%, or approximately 5.23% lower than budget.

The largest revenue source for the general fund is property taxes, which accounts for 64.95% of the 2023 general fund revenue budget. The 2023 budget for this category is projected to be \$1.61 million and would be up by \$150.0 thousand (10.30%) when compared to 2022 full-year collections. To-date, the general fund has received \$1.56 million in property tax revenues from the Licking County Treasurer (97.25% of budget). This total is up by \$170.5 thousand (12.25%) from the same eight-month period in 2022. The increase is the result of an increased assessed valuation of the city due to recent residential construction being added to the tax base.

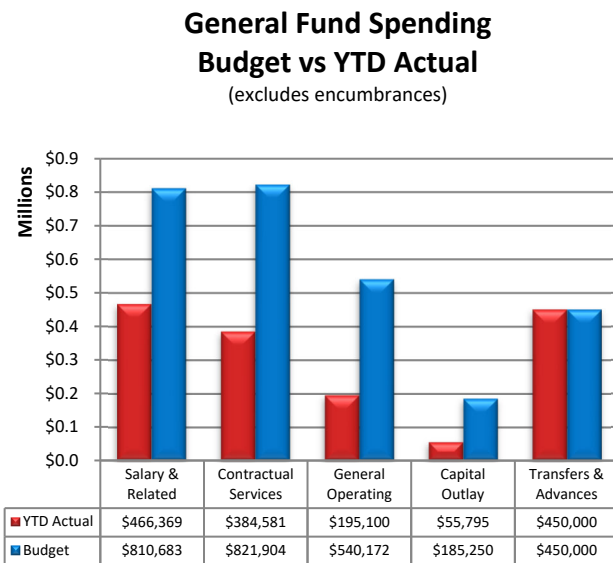
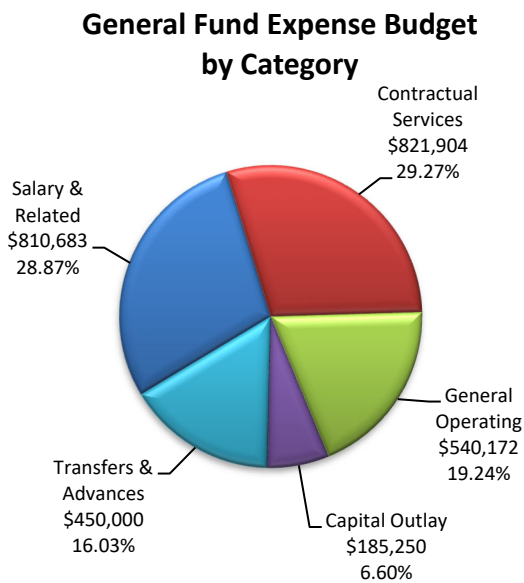
Intergovernmental revenue represents the second largest revenue category for the general fund. It reflects funding received by the city from federal, state and county governments and can come in the form of loans, grants or reimbursements. For 2023, it is projected to account for approximately \$318.3 thousand (12.86% of total fund budget). This category consists of the following revenue items: local government distributions, property tax rollback/homestead exemption reimbursements from the state; electric utility income tax reimbursement; and cigarette/liquor taxes and fees. On a year to-date basis, the fund has received \$105.0 thousand in this category (33.0% of budget) and is down by \$98.8 thousand (48.47%) when compared to the same eight-month period in 2022. The negative variance is primarily the result of the receipt timing of the homestead/rollback payment from the State of Ohio (down \$97.5 thousand) and reduced liquor permit fees (down \$2.9 thousand); partially offset by increased local government fund (LGF) revenue (up \$1.6 thousand).

Service charge revenues is the next major general fund revenue source. These revenues are received in exchange for providing services to residents, businesses and other customers including building

licenses/permits, and other miscellaneous permits. The 2023 budget in this category is \$276.3 thousand (11.17% of budget). Through August 31, the city has received \$173.0 thousand (62.61% of budget) and is up by \$12.5 thousand (7.78%) from FY 2022. The variance is the result of increased franchise fees (up \$40.1 thousand); partially offset by reduced requests for permits from the city in 2022 (down \$18.5 thousand) and reduced variance applications and zoning permit requests (down \$9.2 thousand).

Fines and forfeitures revenue represent the other major revenue category for the general fund. The 2023 budget in this category is \$127.6 thousand (5.16% of budget) and consists of fines and forfeitures generated by the operation of the city’s Mayor’s Court, as well as other state-generated fines. Through August 31, the city has received \$97.6 thousand in this category, which represents 76.49% of budget. Compared to the same eight-month period in 2022, the total is down by \$35.3 thousand, or 26.55%. The primary driver of the decrease is the reduced rate of revenue generated by the Mayor’s Court in 2023.

Expenditures – The general fund has a total appropriated expenditure budget for 2023 of approximately \$2.81 million. Total spending through August 31 is \$1.55 million and is equal to 55.26% of the budget. Including encumbrances (e.g., purchase orders) of \$365.0 thousand (but excluding transfers) in the total results in a total ratio equal to 62.21% of budget. Most of the encumbered balances represent full-year purchase orders which tend to overstate the impact. Compared to the same eight-month period in 2022 (and excluding transfers), the total is up by \$218.9 thousand (24.79%).



Contractual services represents the largest expense category in the General fund. The 2023 budget in this category is \$821.9 thousand (29.27% of budget) and provides for non-employee personal services, such as legal, audit and engineering services. Spending through August 31 is \$384.6 thousand (46.79% of budget). Including encumbrances (e.g., purchase orders) of \$160.0 thousand in the total, 66.26% has been either spent or committed to be spent. It is important to note that much of the spending in this category does not tend to follow a linear path; rather, it is typically disbursed in large ‘chunks’ to the vendors and consultants when the services are provided. We monitor this category closely to ensure that spending remains within budget.

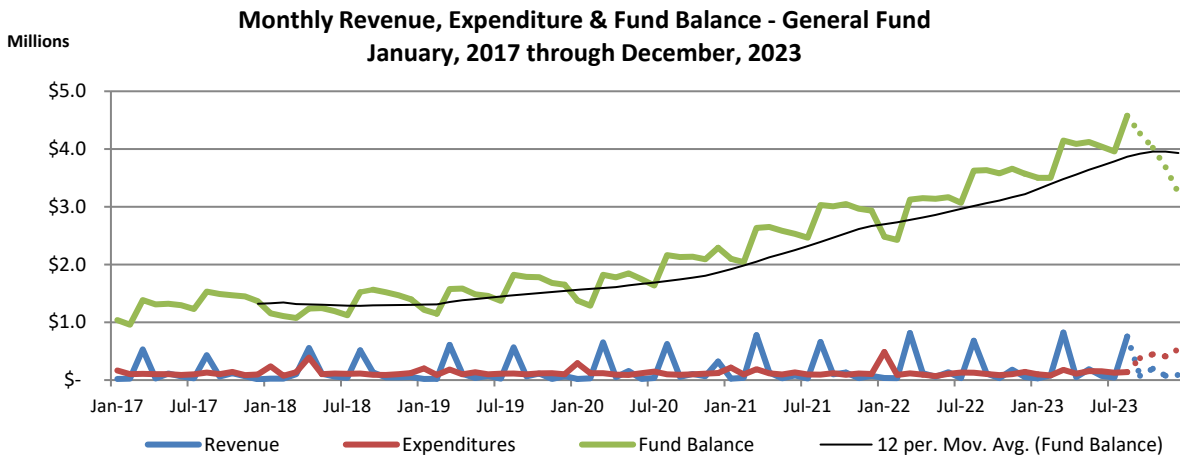
Salaries, wages and other employee-related costs is another major expense category with a 2023 budget of \$810.7 thousand, or 28.87% of the general fund budget. Spending through August 31 was \$466.4 thousand, or 57.53% of budget. The positive variance (\$74.1 thousand below budget) was primarily the result of

reduced insurance premiums, lower employee HRA funding paid to-date and slightly below budget spending on wages due to open positions.

General operating expenditures is another significant expense category in the general fund. It combines a number of other basic types of expenditures including supplies, equipment, utilities and other miscellaneous expenses. It has a 2023 budget of \$540.2 thousand, or 19.24% of the fund’s budget. Year to-date 2023 spending in this category is \$195.1 thousand and is equal to 36.12% of budget. Including encumbrances in the calculation, the total spent or committed is \$332.0 thousand, or 61.45% of budget. Spending in this category is up by \$55.0 thousand (39.26%) from the same eight-month period in 2022.

The approved 2022 budget in the general fund includes \$450,000 in interfund transfers to the Recreation (206) fund to provide additional funding for recreational programming. This is a major increase from FY 2022 which had a total of \$335,000 in interfund transfers. In prior years, the General fund would cover 50% of the wages and benefits for Parks & Recreation employees. Starting in 2022, these costs have been completely charged to the Recreation fund, which results in the fund requiring additional funding. The 2023 transfers were made on the accounting system during the month of February.

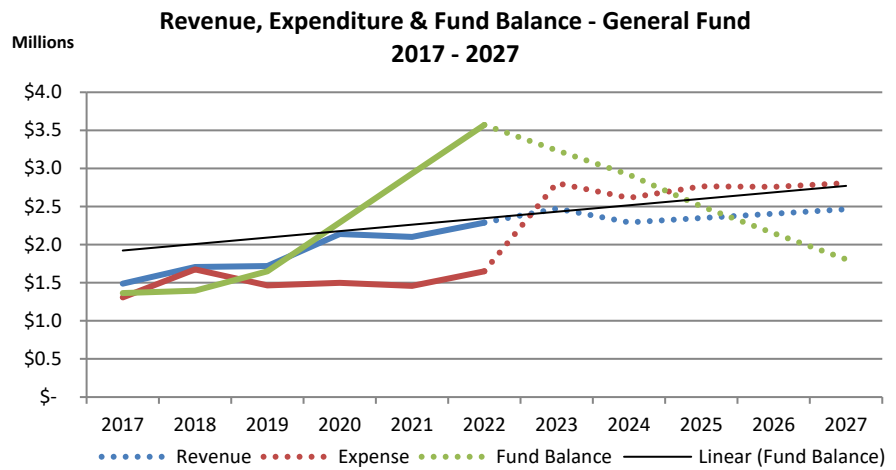
Fund Balance – The general fund is the primary operating account for the city from which expenses, other than those associated with the Street, Police and Debt Service functions, are paid. Fund balance represents the accumulation of prior period revenues minus expenses. The fund balance can be used in future periods to stabilize fluctuations in revenues, or during periods of greater than typical spending. Evaluating the fund balance (and the related revenues/expenses) is a valuable exercise, in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate resources to pay future expenses?).



The chart above plots revenue, expenditures and fund balance on a monthly basis since January 2017. The solid color lines represent historical numbers, and any dotted lines representing projections for the rest of the year. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over the time horizon of the chart. Since 2017, the fund has generally been on an upward trajectory. The approved 2023 budget would have the fund declining by \$333.7 thousand (9.34%) if 100% of the projected revenue was collected and 100% of appropriations spent. The major spikes in revenue (typically March & August) represent the receipt of the semi-annual property tax settlements. The April 2018 and January 2022 spikes reflect interfund transfers of \$250.0 and \$335.0 thousand, respectively, to the Capital Improvements and Recreational Programming funds.

As you can see from the chart at the top of the following page, fiscal years 2017 through 2022 were very positive for the general fund balance, even though the fund had been generally declining over the prior

several years. This improvement was due to both reduced spending and increased revenues received during the year. Of note, spending in the 2017 - 2022 period was less than revenue received which resulted in the increasing fund balance. The fund is projected to be unable to maintain this positive trend in 2023 as the current forecast calls for deficit spending in each future year through 2027. The result of this is a declining fund balance in all future years. This chart has been updated with the approved 2023 budget data and the forecast through 2027. Based upon the numbers, the fund balance is currently projected to be \$1.81 million at the end of FY 2027 and would reflect a carryover ratio of 64.39% which is well above the 25-35% target range in the city's fund balance policy.

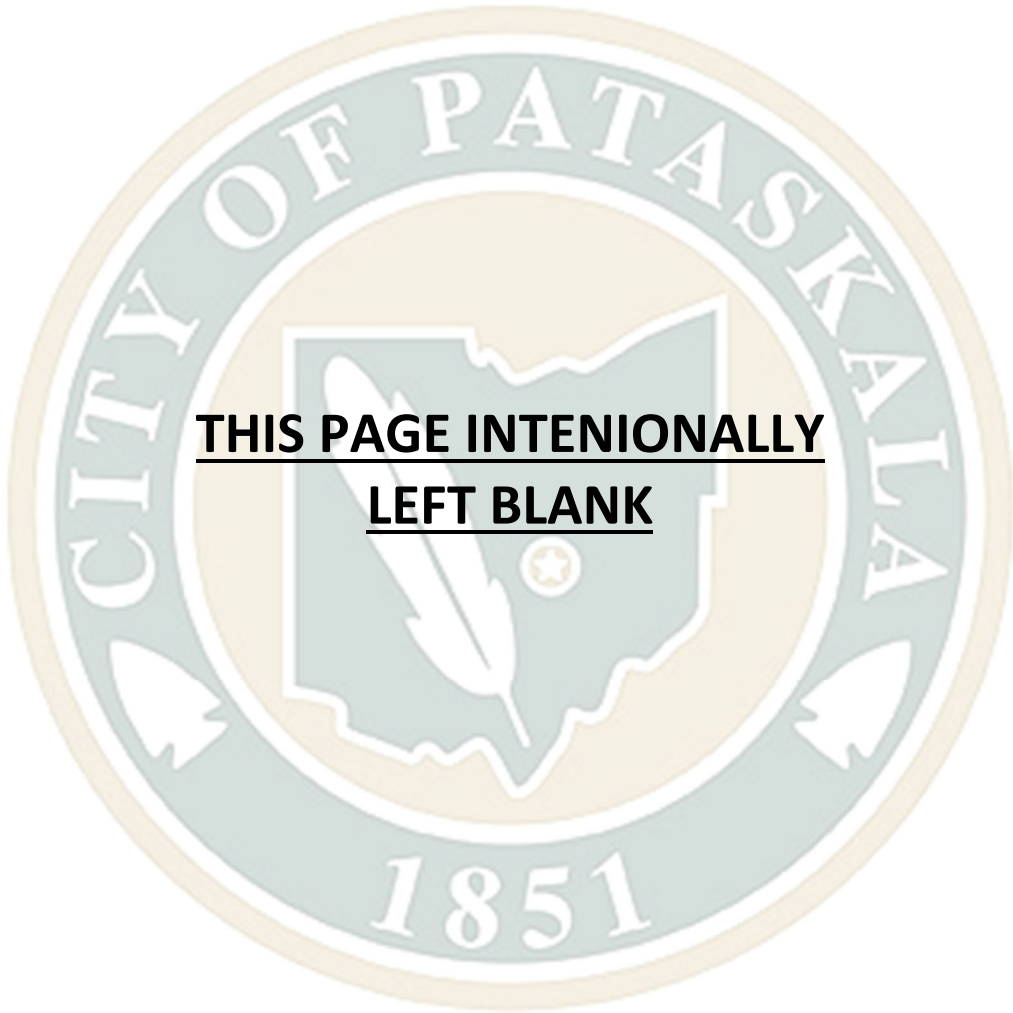

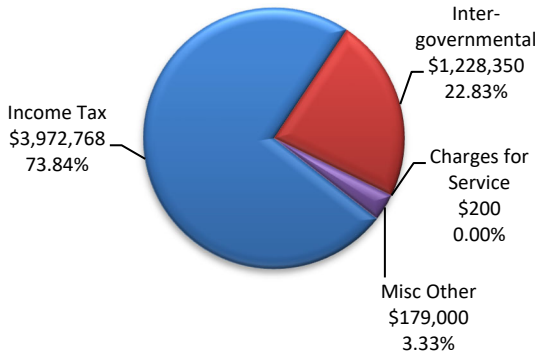

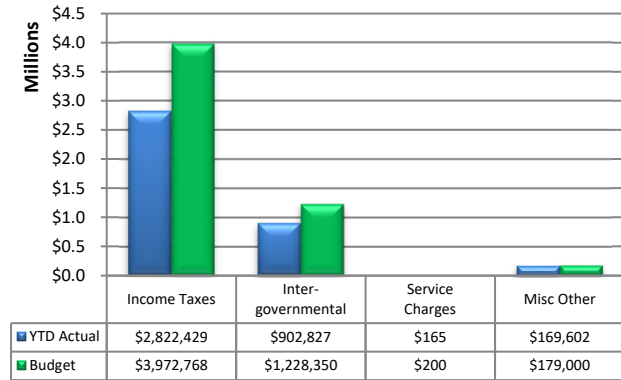
Street Fund (201)

Revenue – The Street Fund has a 2023 revenue budget of approximately \$5.38 million with the fund’s primary revenue sources being income taxes and intergovernmental revenues. On a year to-date basis, the Street fund has been credited with total revenue of approximately \$3.90 million, which reflects 72.39% of the full-year budget. Total revenue to-date is up by \$737.7 thousand (23.36%) from the same eight-month period in 2022.

Street Fund Revenue Budget by Source



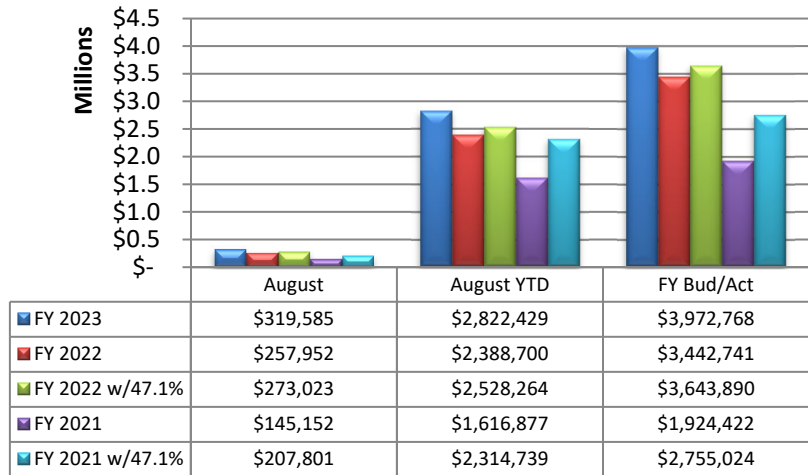
Street Fund Revenue Budget vs YTD Actual



Income tax collections in August were \$319.6 thousand and represent 8.04% of the 2023 budget. Collections for the month are up by \$61.6 thousand (23.89%) higher when compared to the same period in 2022. Year to date income tax revenues credited to the fund are \$2.82 million and represent 71.04% of budget. In comparison, collections through August 2022 were equal to 69.38% of the full-year collections, and in 2021 the rate was 84.02%.

The increase in the fund’s 2023 allocation rate from 44.10% to 47.10% had the effect of increasing the revenue credited to the fund by \$180.1 thousand. The increased level of total collections through August resulted in an increase of \$253.6 thousand. The net impact of these variances is the overall increase in fund revenue of \$433.7 thousand. The green and light blue bars in the chart to the right reflect the revenue that would have been allocated to the fund had the percentage not been modified.

Income Tax Collections - Street Fund



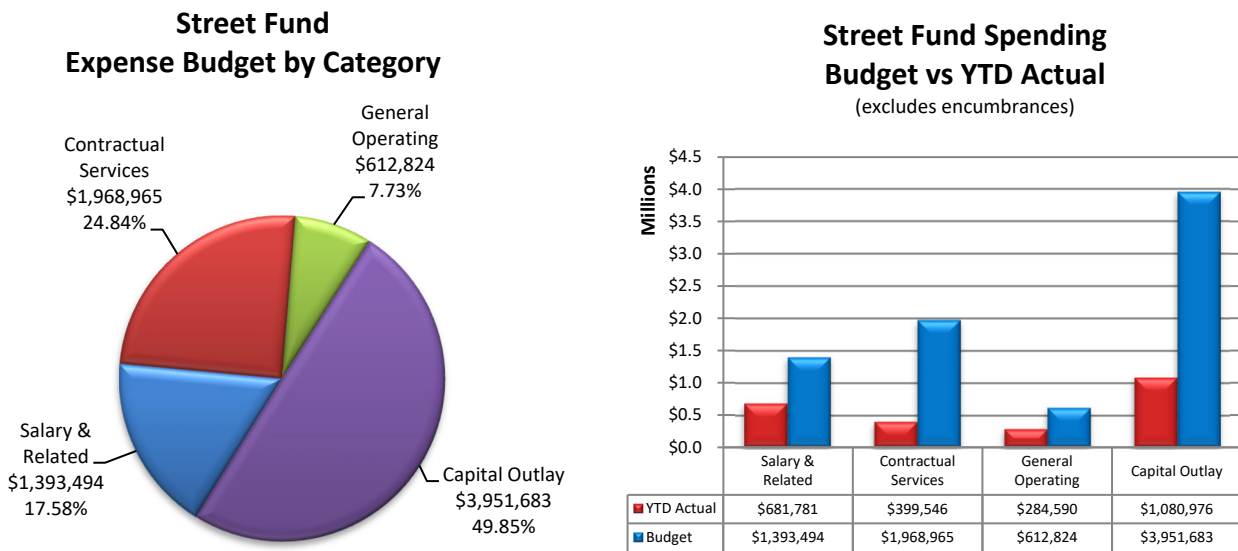
Taking the different allocation rates into consideration, the fund would have received \$294.2 thousand (11.64%) more in 2023 than 2022 had the allocation rate not been changed, and collections would have been \$507.7 thousand (21.93%) higher than 2021 collections.

Intergovernmental revenues in the Street fund are budgeted at \$1.23 million and represent 22.83% of the fund’s revenue budget. They reflect funding received by the city from federal, state and county governments and is comprised of state-shared (e.g., permissive) taxes, and grants/loans from those

governmental agencies. On a year to-date basis, the city has received \$902.8 thousand in this category (73.50% of budget) which is up by \$180.5 thousand (24.99%) from the same eight-month period in 2022.

The other category, Other Sources, is budgeted at \$179.0 thousand and represents only 3.33% of the total fund revenue budget. To date, the city has received \$169.6 thousand (94.75% of budget), which is up by \$123.7 thousand (269.42%) from the same eight-month period in 2022. This variance is primarily the result of improved investment earnings in 2023 (up \$75.9 thousand).

Expenditures – The Street fund has a total appropriated expenditure budget for 2023 of approximately \$7.93 million. Total spending through August 31 was \$2.45 million and is equal to 30.87% of budget. The lower than anticipated spending rate is the result of below budget spending in the Contractual Services and Capital Outlay budget categories. Including encumbrances of \$2.74 million in the total (but excluding transfers) results in total fund spending equal to 65.46% of budget. Compared to year to-date 2022 (and excluding transfers), the total is up by \$1.19 million (94.35%) and is the result of increased spending in all budget categories.



Spending on capital projects and equipment is the largest expense category in the Street Fund with a 2023 budget of \$3.95 million, or 49.85% of the fund’s budget. The budget provides funding for street and roadway infrastructure maintenance and related equipment. Spending through August 31 was \$1.08 million, or 27.35% of budget. The variance is the result of progress payments on infrastructure improvement projects made through August. Including encumbrances (e.g., purchase orders) in the total results in a spending commitment equal to \$3.0 million, or 75.99% of budget.

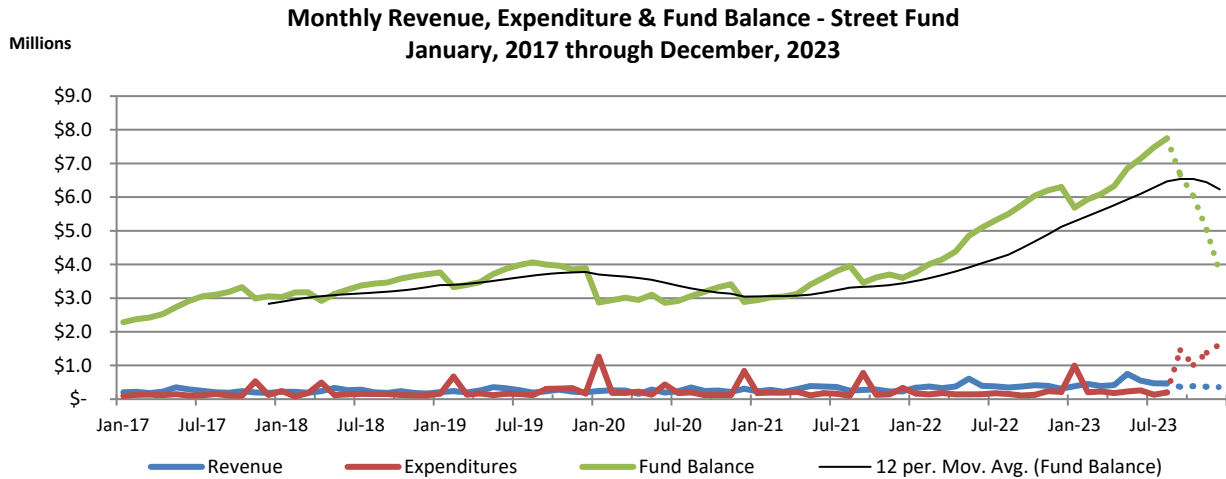
Contractual services represents the next major expense category in the Street fund. The 2023 budget in this category is \$1.97 million (24.84% of budget) and provides for non-employee personal services, such as legal, audit and engineering services. Spending through August 31 is \$399.5 thousand (20.29% of budget). Including encumbrances (e.g., purchase orders) of \$626.5 thousand in the total, 52.11% has been either spent or committed to be spent. It is important to note that much of the spending in this category does not tend to follow a linear path; rather, it is typically disbursed in large ‘chunks’ to the vendors and consultants when the services are provided. We monitor this category closely to ensure that spending remains within budget.

Salaries, wages and other employee-related costs is another major expense category in the Street fund with

a 2023 budget of \$1.39 million, or 17.58% of the fund’s budget. The budget provides funding for paying employee wages, pension costs and fringe benefits. Spending through August 31 was \$681.8 thousand, or 48.93% of budget. The positive budget variance (\$247.3 thousand below budget) is primarily the result of there being less early funding of employee HRA accounts in 2023 and open positions. Spending in this category is up by \$106.4 thousand (18.50%) from the level in 2022 and is the result of increased wage rates/steps partially offset by reduced HRA funding and open positions.

General operating expenditures is the other significant expense category for the Street fund. It combines a number of other basic types of expenditures including supplies, equipment, utilities and other miscellaneous expenses. It has a 2023 budget of \$612.8 thousand, or 7.73% of the fund’s budget. Spending through August 31 was \$284.6 thousand, or 46.44% of budget. Including encumbrances in the calculation, total spending is \$372.8 thousand, or 60.83% of the budget. Spending in this category is up by approximately \$37.4 thousand (15.12%) when compared to the same eight-month period in 2022.

Fund Balance – The Street fund is the primary operating account for the city from which expenses associated with the maintenance of the city’s streets, roads and rights-of-way are paid. Fund balance represents the accumulation of prior period revenues minus expenses. The fund balance can be used in future periods to stabilize fluctuations in revenues, or periods of greater than typical spending. Evaluating the fund balance, revenues, and expenses is a valuable exercise, in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate resources to pay future expenses?).

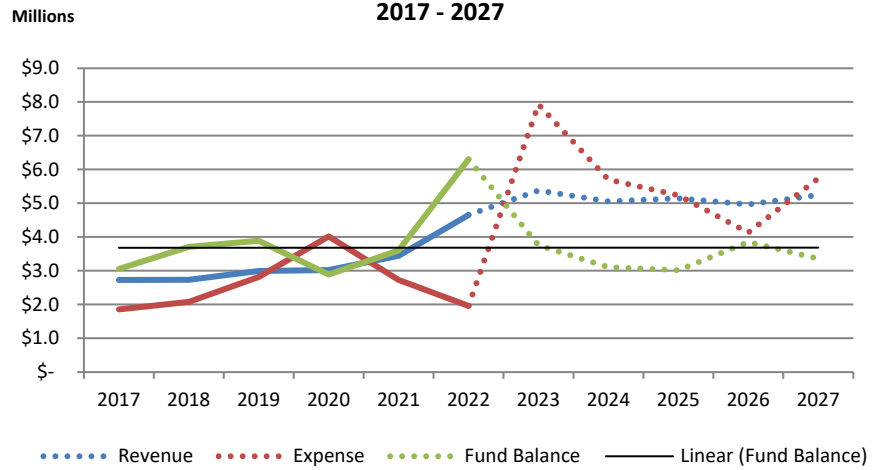


The chart above plots revenue, expenditures and fund balance monthly since January 2017. The solid color lines represent actual numbers, and the dotted lines represent future projections. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over time. The expense spikes, particularly in February 2019, January 2020, December 2020 and January 2022 are the result of paying high-dollar invoices related to construction projects. Other than those items, revenues and spending have been closely matched. Since January 2017, revenues have generally equaled or exceeded expenses, except for large-dollar progress payments on capital improvement projects. In 2023, however, the fund balance is projected to decline by \$2.55 million (40.42%) due to planned roadway and infrastructure improvement projects expected to be completed in 2023. This balance represents a carryover ratio of 47.36% which is above the 25-35% target per city policy.

As you can see from chart at the top of the following page, which has been updated with the approved 2023 budget data through 2027, the balance of the Street fund increased significantly from 2017 – 2022 (with the

exception of 2020 which experienced a fund balance decline). However, current projections also call for the fund balance to significantly decline in 2023-2024 and then somewhat stabilize (although still declining) in 2025. From 2025 and beyond, the fund balance remains somewhat stable between \$3.0 and \$3.9 million. The 2027 year-end carryover balance is currently projected to be \$3.36 million which is equal to 58.57% of planned spending and is higher than policy.

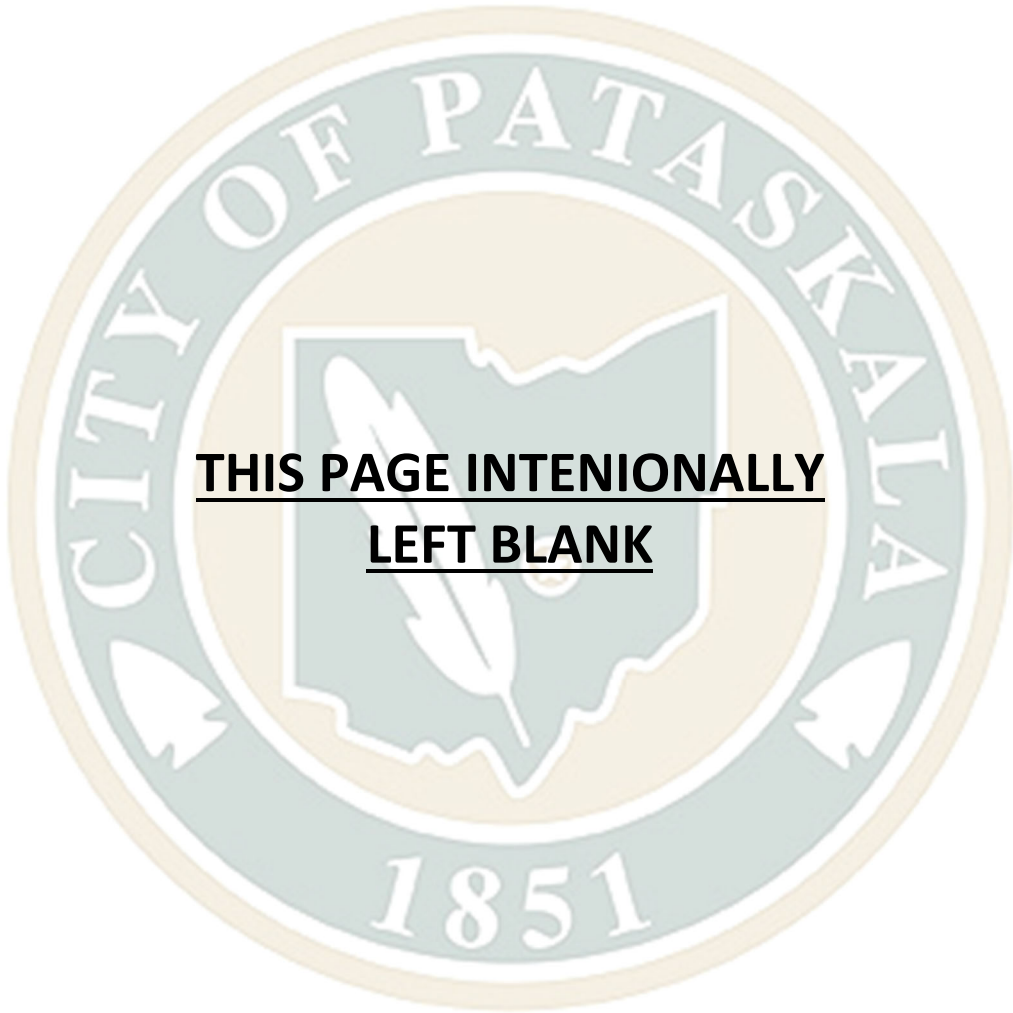

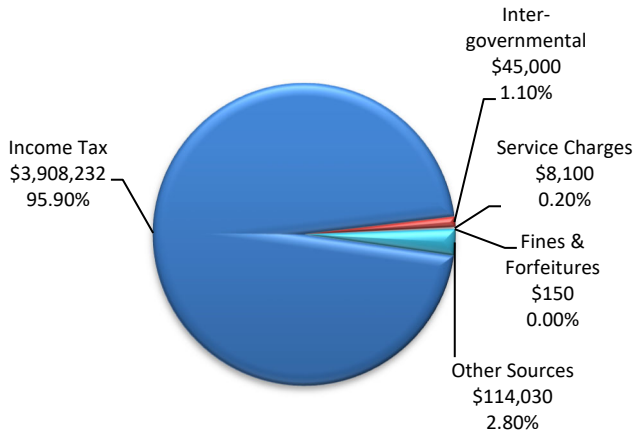

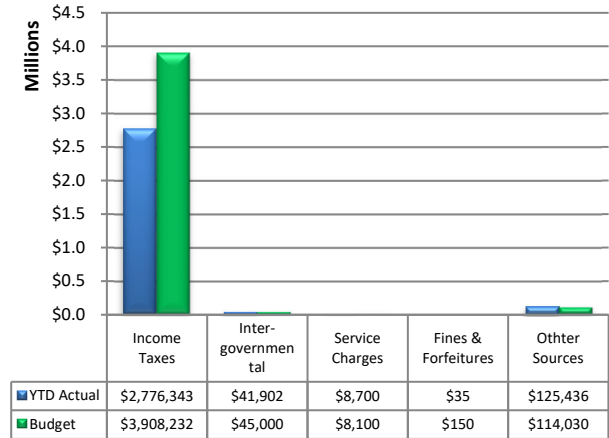
Police Fund (208)

Revenue – The fund’s primary revenue sources are income taxes and other sources, and it has a 2023 total revenue budget of \$4.08 million. On a year to-date basis, the Police Fund has been credited with total revenue of approximately \$2.95 million, which represents 72.44% of budget. Total revenue to-date is \$437.6 thousand (17.40%) higher than that collected during the same eight-month period in 2022. The primary cause of the increase is the higher level of income tax collections in 2023 and the fund receiving a greater portion of the tax revenues than in 2022 (46.3% vs 45.0%).

Police Fund Revenue Budget by Source

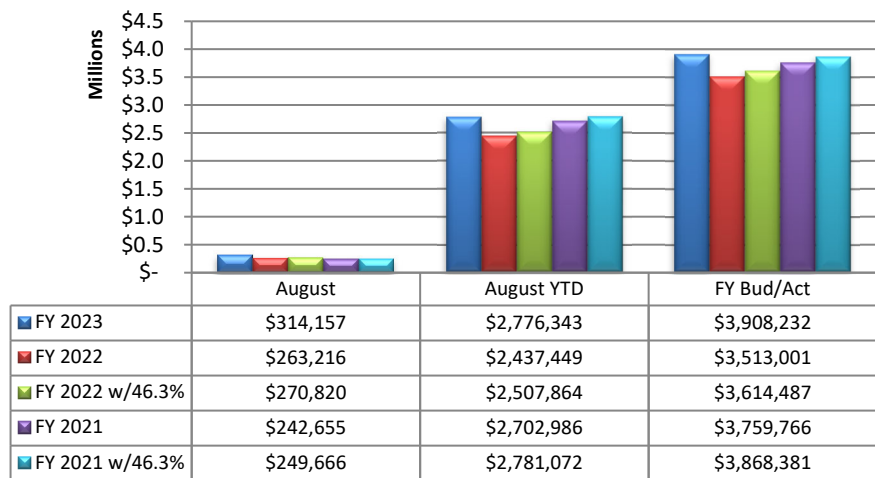


Police Fund Revenue Budget vs YTD Actual



Income tax collections in August were \$314.2 thousand and are up by \$50.9 thousand (19.35%) when compared to the same period in 2022 and are equal to 8.04% of budget. Year to date income tax revenues credited to the fund are \$2.78 million and represent 71.04% of budget. In comparison, collections through August 2022 were \$2.44 million, and reflected 69.38% of the 2022 full-year collections. In 2021, the rate was equal to 71.89% of full-year collections. The increase in the fund’s 2023 allocation rate from 45.0% to 46.3% had the effect of increasing the revenue credited to the fund by \$78.0 thousand. The increased level of total collections through August resulted in an increase of \$260.8 thousand. The net impact of these variances is the overall increase in fund revenue of \$338.9 thousand. The green and light blue bars in the chart to the right reflect the revenue that would have been allocated to the fund had the percentage not been modified.

Income Tax Collections - Police Fund



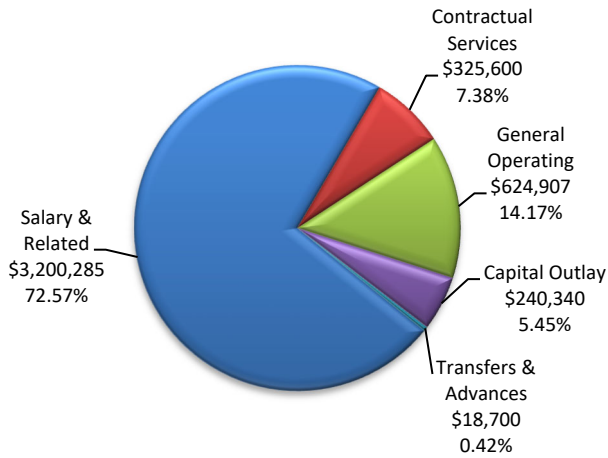
Taking the different allocation rates into consideration, the fund would have received \$268.5 thousand (10.71%) more

in 2023 than 2022 had the allocation rate not been changed, and collections would have been \$4.7 thousand (0.17%) lower than the 2021 collections.

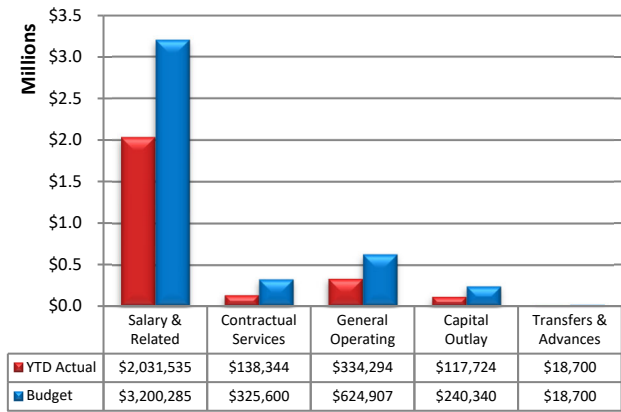
The other significant revenue category, Other Sources, is budgeted at \$114.0 thousand, and represents only 2.80% of the total fund revenue budget. To date, the city has received \$125.4 thousand (110.0% of budget) and is up by \$68.5 thousand (120.26%) from the same eight-month period in 2022. This variance is primarily the result of improved investment earnings in 2023 (up \$41.1 thousand).

Expenditures – The Police fund has a total appropriated expenditure budget for 2023 of approximately \$4.41 million. Total spending through August 31 is approximately \$2.64 million and is equal to 59.88% of budget. Excluding interfund transfers of \$18.7 thousand, total spending is equal to 59.71% of budget. Including encumbrances (e.g., purchase orders) of \$405.0 thousand in the total results in total spending equal to 68.93% of budget. Compared to the same eight-month period in 2022 (and excluding transfers), the total is up by \$355.6 thousand (15.69%) and is primarily the result of increased spending in the Salary & Related and General Operating budget categories, partially offset by reduced interfund transfers.

Salaries, wages and other employee-related costs represent the largest expense category with a 2023 budget of \$3.20 million, or 72.57% of the fund’s budget. Spending through August 31 was \$2.03 million, or 63.48% of budget and is \$102.1 thousand (3.19%) below budget. The variance is the result of there being less early funding of employee HRA accounts in 2023. Spending in this category is up by \$266.9 thousand (15.13%) from the level in 2022 and is also the result of there being open positions in 2022 and the large wage scale/step increase in mid-year 2022.

General operating expenditures is the next major expense category in the Police fund. It combines a number of other basic types of expenditures including supplies, equipment, utilities and other miscellaneous expenses. It has a 2023 budget of \$624.9 thousand, or 14.17% of the total fund expenditure budget. Year to-date spending in this category is \$334.3 thousand, or 53.49% of budget and is up by \$35.0 thousand (11.70%) from the same eight-month period in 2022.

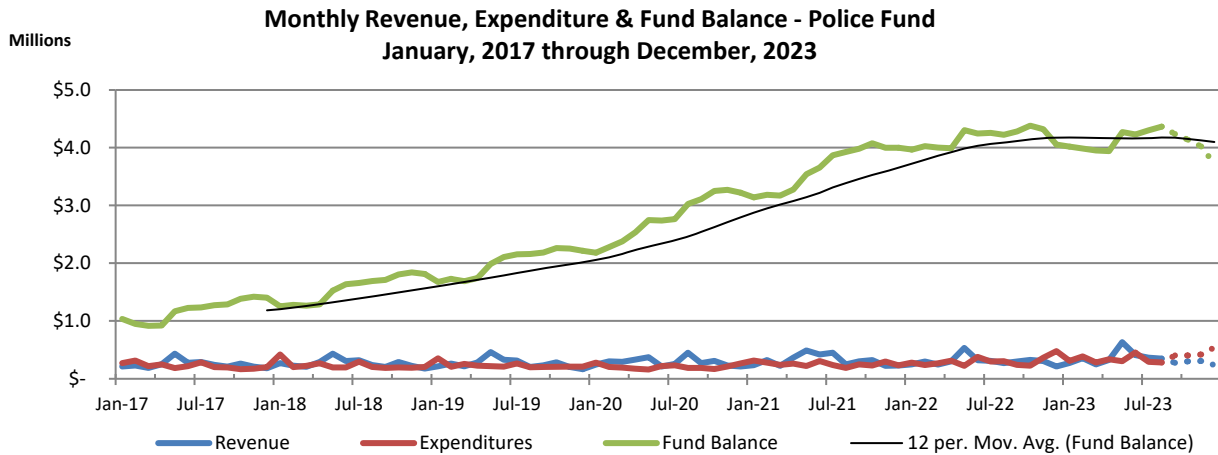
Contractual services is another major expense category in the Police fund. The 2023 budget in this category is \$325.6 thousand (7.38% of budget) and provides for non-employee personal services, such as legal, audit, facility management and other law enforcement-related services. Spending through August 31 is \$138.3

thousand (42.49% of budget). Including encumbrances (e.g., purchase orders) of \$63.6 thousand in the total, 62.02% has been either spent or committed to be spent. It is important to note that much of the spending in this category does not tend to follow a linear path; rather, it is typically disbursed in large ‘chunks’ to the vendors and consultants when the services are provided. We monitor this category closely to ensure that spending remains within budget.

Spending on capital equipment is another significant expense category in the Police fund. The 2023 budget in this category is \$240.3 thousand (5.45% of total fund budget) and provides funding for the acquisition of Police cruisers, law enforcement-related equipment and other capital improvements. Year to-date spending in this category is \$117.7 thousand (48.98% of budget) and is up by \$35.8 thousand (43.74%) from the same eight-month period in 2022.

The approved 2023 budget in the Police fund includes an interfund transfer of \$18.7 thousand. The purpose of the transfer is to provide funding to the Debt Service (401) fund to meet the department’s financial obligations on the LGIF loan for the construction of the MARCS tower. This transfer was completed during the month of February and is the final year for such a transfer as the debt will be paid off in 2023.

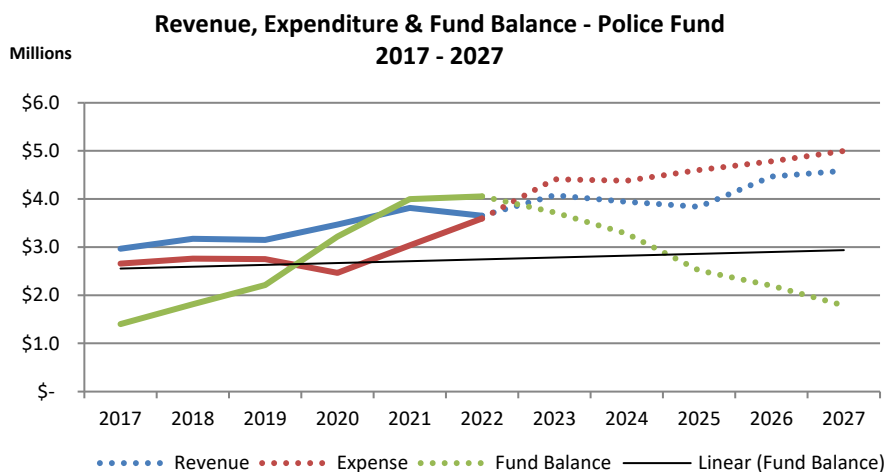
Fund Balance – The Police fund is the primary operating account for the city from which expenses associated with the operation of the city’s Police department are paid. Fund balance represents the accumulation of prior period revenues minus expenses. The fund balance can be used in future periods to stabilize fluctuations in revenues or periods of greater than typical spending. Evaluating the fund balance, revenues, and expenses is a valuable exercise, in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate resources to pay future expenses?).



The chart above plots monthly revenue, expenditures and fund balance since January 2017. The solid color lines represent actual numbers, and the dotted lines represent projections for the rest of the year. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over the time horizon of the chart. As you can see from the chart, the balance in the Police fund has been fluctuating up and down since January 2017 but has seen growth since mid-2017. In general, revenues and expenditures have been closely matched.

Current projections call for the balance to decline in starting in 2023 and continuing to do so through 2027. However, the fund ended 2022 at a balance of \$4.05 million or \$502.5 thousand better than projected. The carryover balance at this point reflects a reserve ratio of 84.34%. The fund is projected to decline annually

through 2027 when it will have a projected year-end balance of \$1.78 million, which would represent a 35.75% carryover balance. This is slightly above the 25-35% target range per policy. The chart at right has been updated with the approved 2023 budget data through 2027.

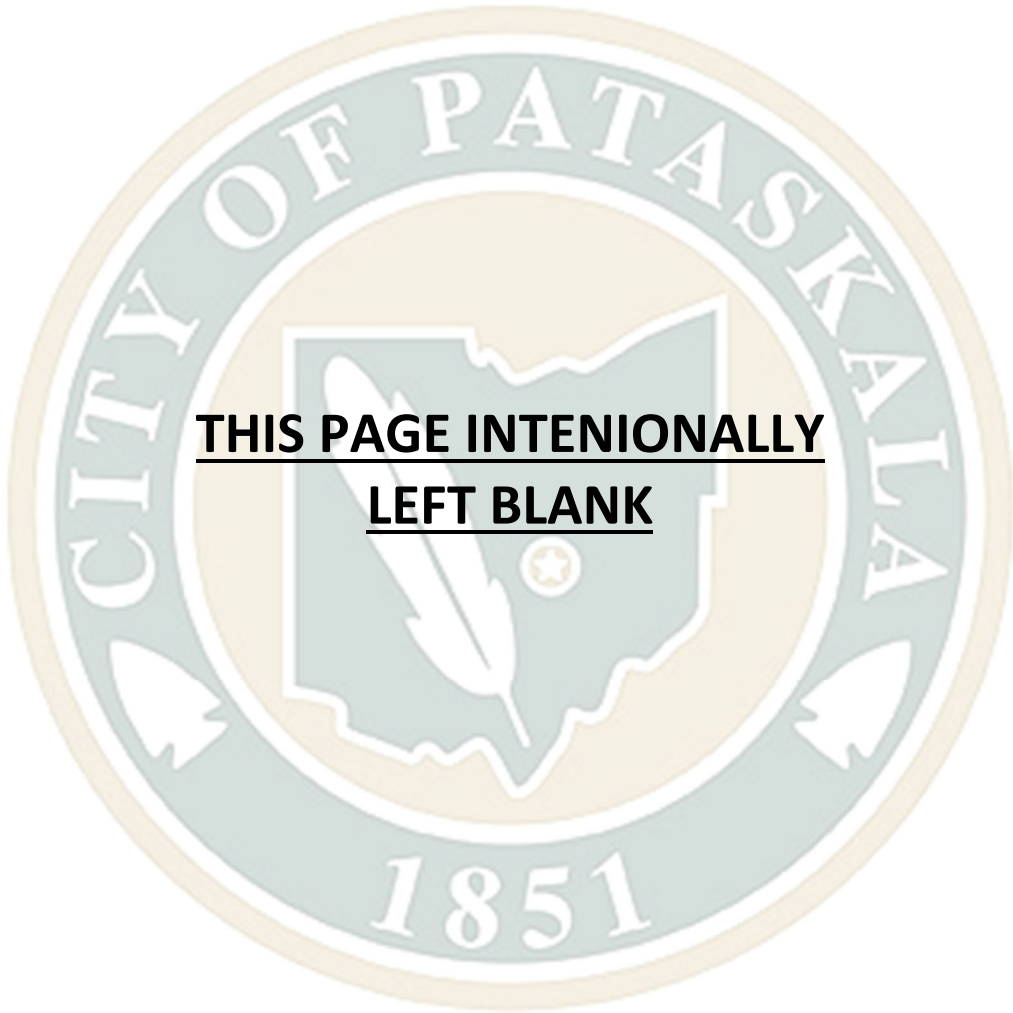

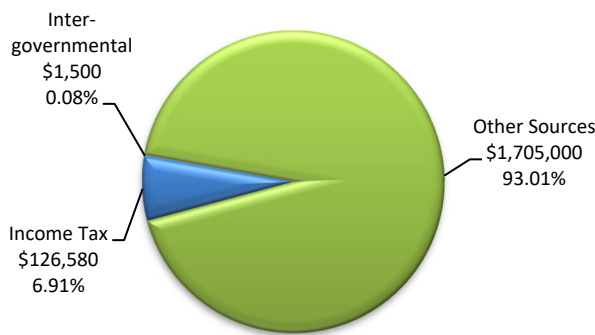

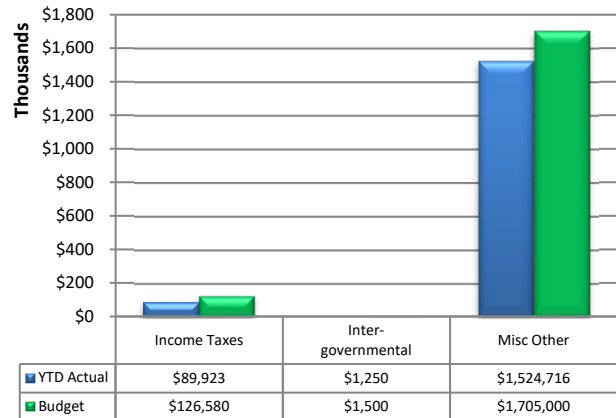
Capital Improvements Fund (301)

Revenue – The Capital Improvements Fund has a 2023 revenue budget of approximately \$1.83 million. The fund’s primary revenue sources are income taxes, intergovernmental revenues and interfund transfers. On a year-to-date basis, the Capital Improvements fund has been credited with total revenue of approximately \$1.62 million, which represents 88.15% of the budget. Excluding the impact of \$1.66 million in one-time developer-provided funds, the eight-month total is at 66.96% of budget and is slightly higher than expectations when compared to the 66.67% straight-line rate. The fund is slated to receive a 1.50% allocation of income tax revenues in 2023, which is unchanged from allocation rate to the fund in 2022.

Capital Improvements Fund Revenue Budget by Source

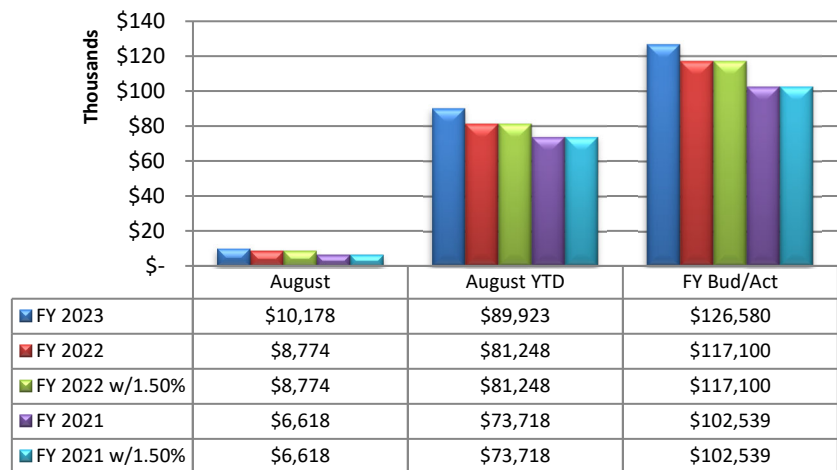


Capital Improvements Fund Revenue Budget vs YTD Actual



Other than \$1.66 million in one-time pass-through developer-provided funds for the Refugee Road project, income taxes are the primary external revenue source in 2023 for the Capital Improvements fund representing 6.91% of the fund’s total revenue sources. Income tax collections in August were \$10.2 thousand and represent 8.04% of the 2023 budget. Collections are up by \$1.4 thousand (16.0%) when compared to the same period in 2022. Year to date income tax revenues credited to the fund are \$89.9 thousand and represent 71.04% of budget. In comparison, collections through August 2022 were \$81.2 thousand, and reflect 69.38% of the 2022 full-year collections. In 2021, the rate was equal to 71.89% of full-year collections. The overall higher level of total tax collections through August resulted in an increase of \$8.7 thousand as the allocation rate remained unchanged in 2023 from 2022. The green and light blue bars in the chart to the right reflect the revenue that would have been allocated to the

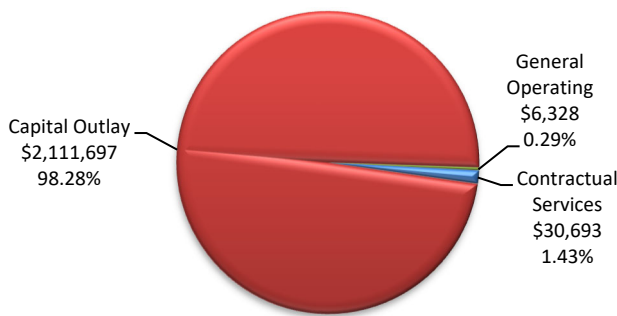
Income Tax Collections Capital Improvements Fund



fund had the percentage not been modified. Since the allocation has not changed since 2021, there is no difference in the allocations and a comparison would not be relevant.

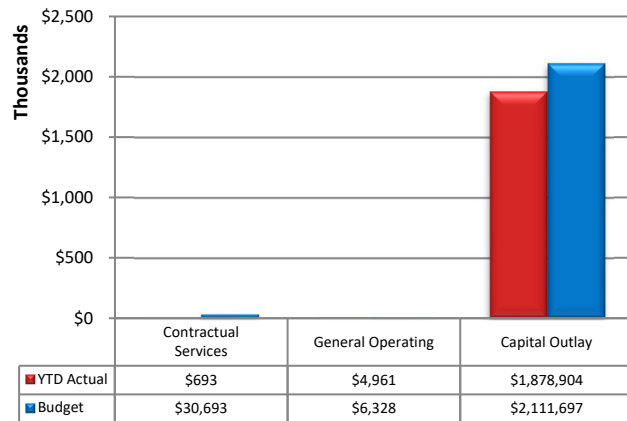
Expenditures – The Capital Improvements fund has a total appropriated expenditure budget for 2023 of approximately \$2.15 million. Total spending through August 31 was \$1.88 million and is equal to 87.71% of the budget. Including encumbrances (e.g., purchase orders) of \$41.7 thousand in the total results in total spending equal to 89.65% of budget. Compared to the same eight-month period in 2022 (and excluding transfers), the total is up by \$1.08 million (135.56%) and is due to increased spending in the Capital Outlay category partially offset by reduced spending in the Contractual Services budget category.

As would be expected, spending on capital projects and equipment is the major expense category in the Capital Improvements fund. The 2023 budget in this category is \$2.11 million, (98.28% of budget), and provides funding for the construction of a number of infrastructure improvements. Spending through August 31 was \$1.88 million and represents 88.98% of the category’s budget. The primary planned expenditures in this category are related to the Refugee Road improvements project, the City Hall elevator improvements, Old Town Hall improvements and various park facility improvement projects. The 2023 budget in this category is \$30.7 thousand (1.43% of budget) and provides for non-employee personal services, principally engineering and construction inspection services. Spending through August 31 was \$0.7 thousand in this category. It is important to note that much of the spending in this category does not tend to follow a linear path; rather, it is typically disbursed in large ‘chunks’ to the vendors and consultants when the services are provided. We monitor this category closely throughout the year to ensure that spending remains within the approved budget. The projects planned in this category for 2023 include the following:

General Operating is the other expense category in the Capital Improvements fund. The 2023 budget in this category is \$6.3 thousand (0.29% of budget) and provides for other non-capital operating expenditures incurred by the fund. Spending through August 31 was \$5.0 thousand and represents 78.40% of the category’s budget. Spending planned in this category in 2023 is for the payment of income tax collection fees and taxpayer refunds to RITA.

Fund Balance – The Capital Improvements fund is the primary capital fund account for the city from which expenses associated with the construction of infrastructure improvements and purchase of equipment are paid. Fund balance represents the accumulation of prior period revenues minus expenses and can be used in future periods to stabilize fluctuations in revenues or periods of greater than typical spending. Evaluating the fund balance, revenues, and expenses is a valuable exercise, in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate resources to pay future expenses?).

The fund ended 2022 with an unencumbered balance of \$1.73 million, which was up by \$71.0 thousand (429%) from FY 2021. The unencumbered balance equates to a reserve ratio equal to 343.55% of expenditures which is outstanding and provides the ability for the city to fund future projects (e.g., Parks, Streets, etc.). FY 2021 ended the year with an unencumbered balance of \$1.54 million, which was up by \$164.2 thousand (13.23%) from FY 2020. In comparison, the 2023 budget projects a year-end fund balance of \$1.39 million, which would equate to a reserve ratio equal to 64.81% of expenditures. The higher ratio at year-end 2023 is the result of reduced spending planned from this fund during the year, partially offset by the lower starting carryover balance.

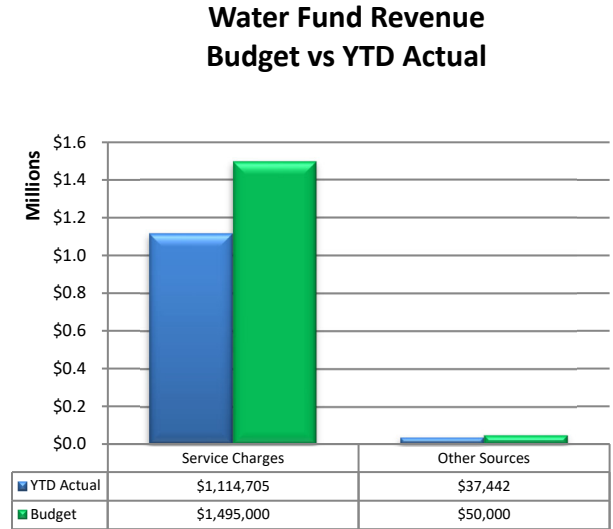
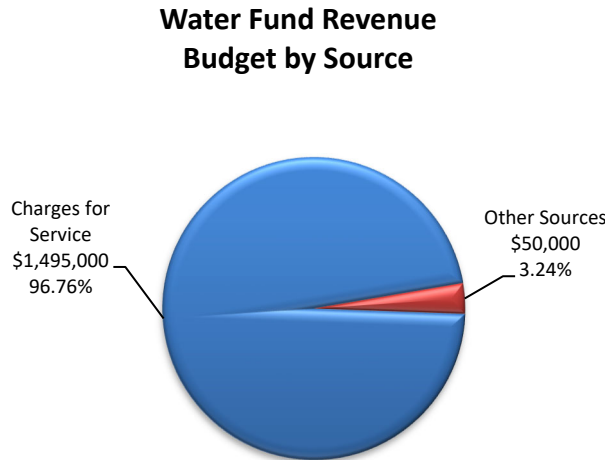

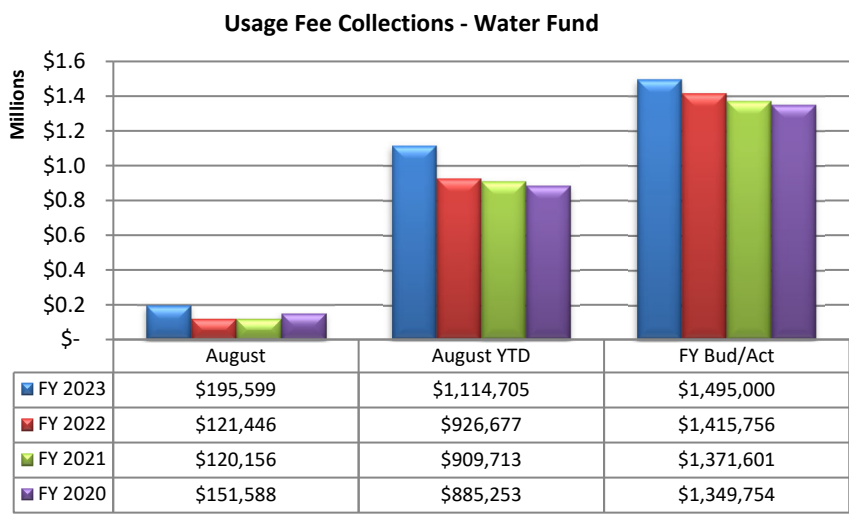

Water Operations Fund (601)

Revenue – The Water Operations fund’s primary revenue sources are charges for service and other sources, and it has a 2023 revenue budget of approximately \$1.55 million. On a year-to-date basis, the fund has been credited with total revenue of approximately \$1.15 million, which represents 74.57% of budget. The total revenue amount is up by \$215.6 thousand (23.02%) when compared to the same eight-month period in 2022.



Charges for service represent the primary revenue category in this fund and are generated by water customer billings. The 2023 budget for this category is \$1.50 million, or 96.76% of the fund’s budget. Year to-date revenues credited to the fund are \$1.11 million, or 74.56% of budget. In comparison, collections



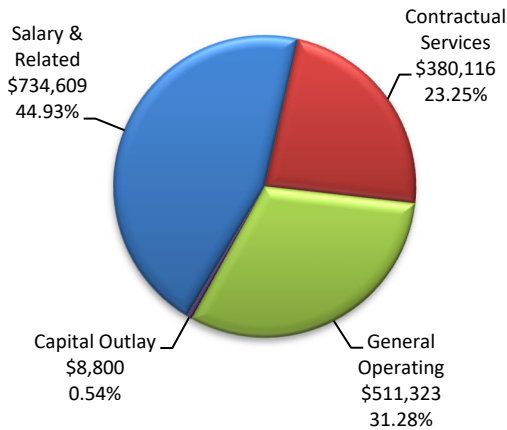
for the same eight-month period in 2022 were \$926.7 thousand and were about 65.45% of full-year collections. The 2023 collections amount to date represents an increase of \$188.0 thousand (20.29%) in 2023 over collections in 2022.

The other category, Other Sources has a 2023 budget of \$50.0 thousand, or 3.24% of the fund’s budget. These revenues vary widely in nature and are relatively insignificant to the total. To date, the city has received \$37.4 thousand and accounts for investment income, as well as any other miscellaneous non-usage related fees and charges.

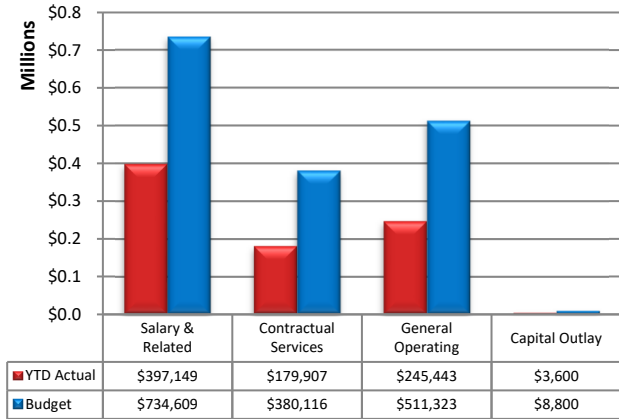
Expenditures – The Water Operations fund has a total appropriated expenditure budget for 2023 of approximately \$1.63 million. Total spending through August 31 was approximately \$826.1 thousand, or 50.53% of budget. Including encumbrances (e.g., purchase orders) of \$361.1 thousand in the total results

in total committed spending equal to 72.62% of budget. Compared to the same eight-month period in 2022 (and excluding transfers), the total is up by \$39.1 thousand (4.97%) and is the result of increased spending in all budget categories.

Salaries, wages and other employee-related costs represent the largest expense category with a 2023 budget of \$734.6 thousand, or 44.93% of the fund’s budget. Spending through August 31 was \$397.1 thousand and is equal to 54.06% of budget. The positive budget variance (\$92.6 thousand below budget) is the result of there being open positions and reduced funding of employee HRA accounts in 2023. Spending in this category is up by \$12.5 thousand (3.26%) from the level in 2022 and is the result of increased wage rates/steps and employee HRA funding in 2023.

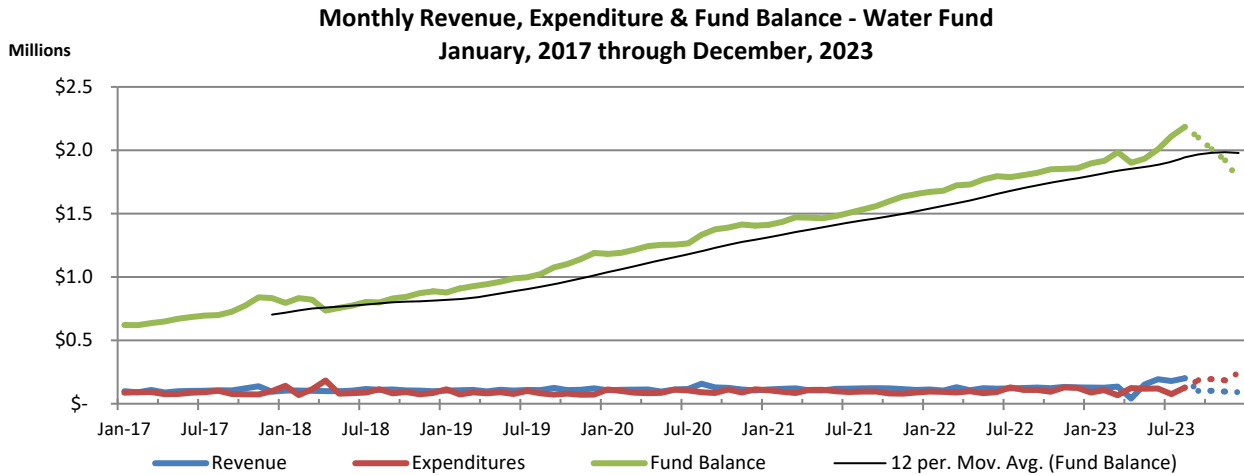
General operating expenses represent the other major expense category. It combines a number of other basic types of expenditures including operating supplies, equipment, utilities and other miscellaneous expenses. It has a 2023 budget of \$511.3 thousand, or 31.28% of the fund budget. Spending through August 31 was \$245.4 thousand, or 48.0% of budget. Including encumbrances of \$167.5 thousand in the calculation results in a total spending commitment of \$413.0 thousand, or 80.77% of budget. Many of these 2023 purchase orders encumber full-year spending and have the effect of overstating the impact of the encumbrances. Spending in this category is up by \$15.3 thousand (6.66%) when compared to the same eight-month period in 2022 and is due to increased spending on supplies/materials (up \$8.2 thousand), increased miscellaneous expenses (up \$8.1 thousand) and reduced spending on equipment and maintenance (up \$6.5 thousand); partially offset by reduced utility costs (down \$7.5 thousand).

The approved 2023 budget in the Water Operations fund does not provide for an interfund transfer to the Water Debt Service (604) fund to assist in meeting the department’s debt service financial obligations. The last time this was required was in 2018. Prior to that, the operating budgets did not provide for any interfund transfers during the previous two years (2016 and 2017).

Fund Balance – The Water Operations fund is the primary operating account for the city from which expenses associated with the operation of the city’s water treatment and distribution operations are paid. Fund balance represents the accumulation of prior period revenues minus expenses. The fund balance can be used in future periods to stabilize fluctuations in revenues, or during periods of greater than typical spending. Evaluating the fund balance (and the corresponding revenues and expenses) is a valuable exercise in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate

resources to pay future expenses?).

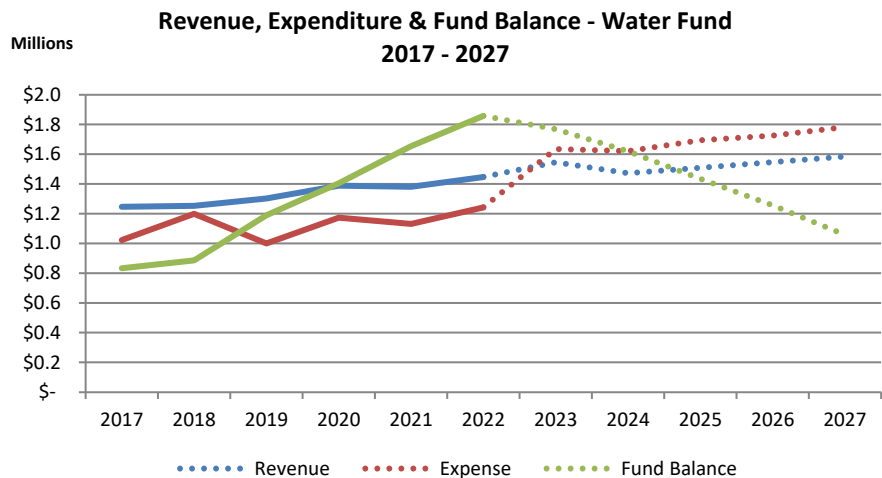
The chart below plots revenue, expenditures and fund balance since January 2017. The solid color lines represent actual numbers, and the dotted lines represent projections for the rest of the year. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over the time horizon of the chart.



The fund ended 2022 with an unencumbered fund balance of \$1.73 million, which was \$184.8 thousand (11.99%) higher than year-end 2021 and was equal to 125.4% of FY 2022 spending. In contrast, the FY 2023 budget projects a year-end fund balance of \$1.77 million, which would equate to a reserve ratio equal to 108.17% of expenditures. The fund ended 2021 with an unencumbered fund balance of \$1.54 million, which was \$299.3 thousand (24.11%) higher than year-end 2020 and was equal to 90.59% of FY 2021 spending.

As you can see from the chart below, the balance in the Water Utility fund has been fluctuating between \$833 thousand and \$1.86 million. The trend line illustrates that the overall trend, however, is that the fund balance is a steady increase in fund balance over the 5-year period. The April 2018 spike in spending is the result of transfers to the water debt service (604) fund. Except for that anomaly, revenues have generally been in excess of expenditures resulting in the trend line to be positively sloped.

During 2021, the year-end balance in the fund increased to approximately \$1.65 million, and it increased to \$1.86 million at year-end 2022. From 2023 through 2027, however, the fund balance is expected to decline to \$1.06 million (59.32% carryover ratio) at the end of FY 2027 (see chart at right). This chart has been updated with the approved 2023 budget data through 2027.

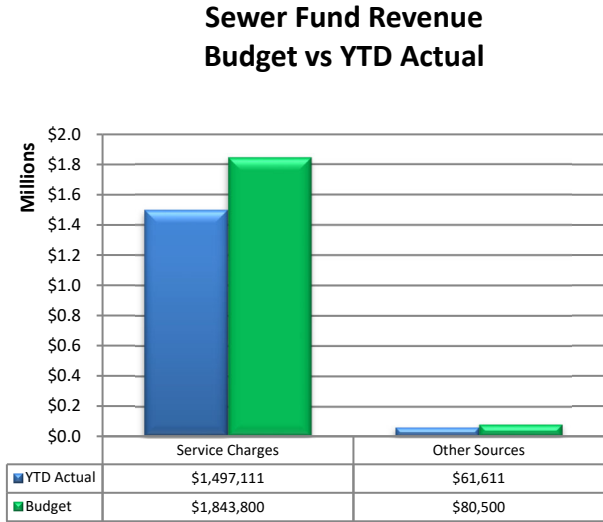
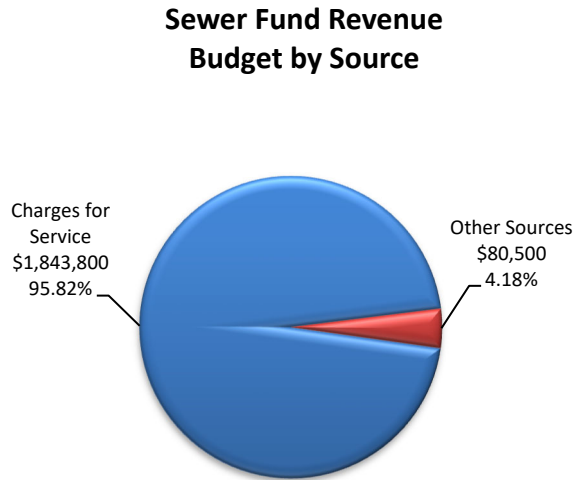

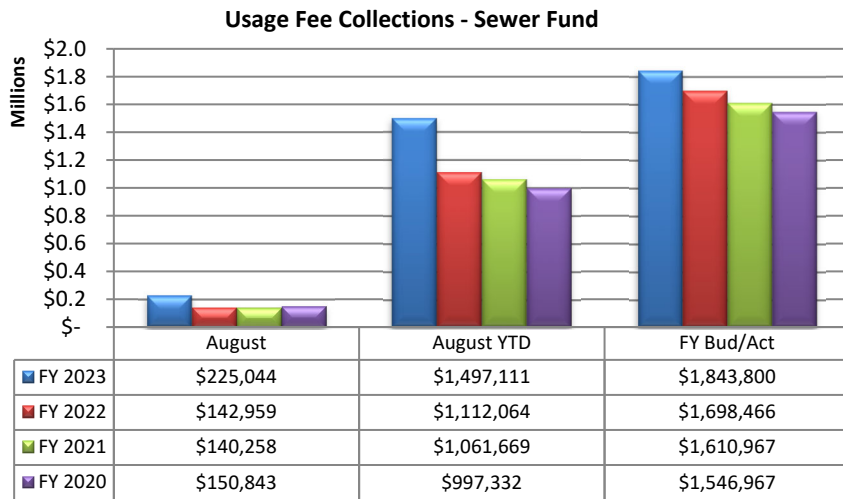

Sewer Operations Fund (651)

Revenue – The Sewer Operations fund’s primary revenue sources are charges for service and other sources, and the fund has a 2023 revenue budget of approximately \$1.92 million. On a year-to-date basis, the fund has been credited with total revenue of approximately \$1.56 million, which represents 81.0% of budget. The total is up by \$429.8 thousand (38.07%) from the same eight-month period in 2022.



Charges for service represent the primary revenue category in this fund and have a 2023 budget of approximately \$1.84 million (95.82% of budget). Year to-date revenues credited to the fund are approximately \$1.5 million, or 81.20% of budget. In comparison, collections for the same eight-month



period in 2022 were \$1.11 million, an increase of \$385.0 thousand (34.62%) in 2023 over 2022.

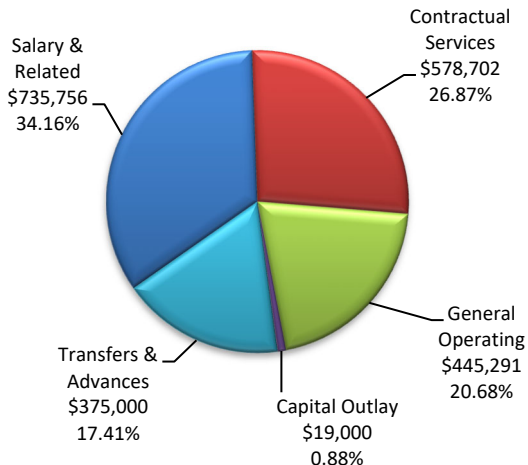
The other revenue category, Other Sources, has a 2023 budget of \$80.5 thousand. These revenues can vary widely and are not material to the total. To date, the city has received \$61.6 thousand, which is \$44.7 thousand (265.3%) higher than FY 2022. The revenues account for investment income, as well as

any other miscellaneous non-usage related fees and charges.

Expenditures – The Sewer Operations fund has a total appropriated expenditure budget for 2023 of approximately \$2.15 million. Total spending through August 31 was approximately \$1.23 million, or 57.05% of budget. Excluding interfund transfers from the calculation results in spending equal to 57.99% of budget. Including encumbrances (e.g., purchase orders) of \$341.2 thousand in the total results in total committed

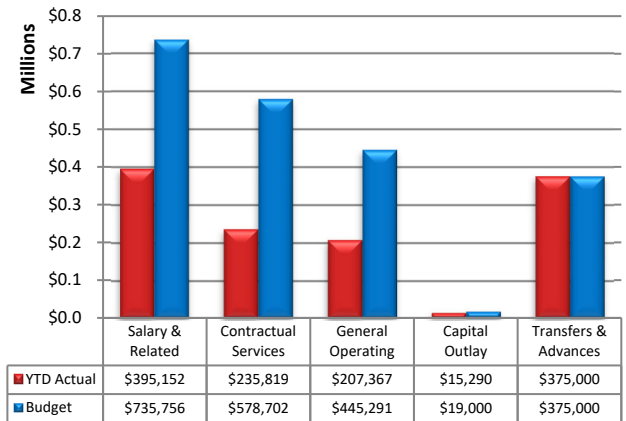
spending equal to 67.17% of budget. Compared to the same eight-month period in 2022 (and excluding transfers), the total is up by \$42.6 thousand (5.25%) and is due to increased spending in most budget categories; partially offset by decreased spending in the General Operating budget category.

(excludes encumbrances)



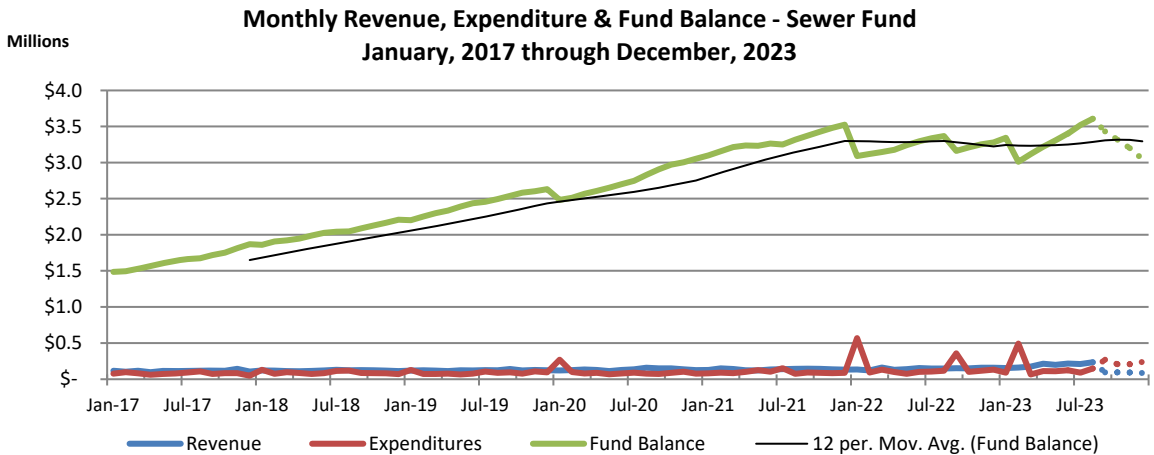
For 2023, the largest expense budget category for the Sewer fund is salaries, wages and other employee-related costs with a budget of \$735.8 thousand, or 34.16% of the total fund budget. Spending through August 31 was \$395.2 thousand, or 53.71% of the budget. The positive budget variance (\$95.4 thousand below budget) is primarily the result of there being open positions and reduced employee HRA account funding. Spending in this category is up by \$13.3 thousand (3.49%) from the level in 2022 and is the result of increased wage rates/steps and employee HRA funding in 2023.

Contractual services is the next major expense category in the Sewer fund. The 2023 budget in this category is \$578.7 thousand (26.87% of budget) and provides for non-employee personal services. Spending through August 31 is \$235.8 thousand (40.75% of budget). Including encumbrances (e.g. purchase orders) in the total, results in a finding that 74.51% of the budget has been either spent or committed to be spent. It is important to note that much of the spending in this category does not tend to follow a linear path; rather, it is typically disbursed in large ‘chunks’ to the vendors and consultants when the services are provided. We regularly monitored this category closely during 2022 to ensure that spending remained within the approved budget and will continue to do so in 2023.

General operating expenditures represent another major expense category. It combines a number of other basic types of expenditures including operating supplies, equipment, utilities and other miscellaneous expenses. It has a 2023 budget of \$445.3 thousand, or 20.68% of the fund budget. Spending through August 31 was \$207.4 thousand, or 46.57% of budget. Including encumbrances (e.g., purchase orders) of \$76.0 thousand in the total results in a spending ratio of 63.63% of budget. Many of these 2023 purchase orders encumber full-year spending and have the effect of overstating the impact of the encumbrances. Compared to the same eight-month period in 2022, spending in this category is down by \$0.5 thousand, or 0.25%.

The approved 2023 budget included total interfund transfers of \$375.0 thousand which is being transferred to the Sewer Debt Service (654) fund to meet the department’s obligations on the system’s portion of the outstanding utility-related debt. This was a significant change as there weren’t any interfund transfers in 2016 through 2019 for debt service funding support. This transfer was made during the month of February.

Fund Balance – The Sewer Operations fund is the primary operating account for the city from which expenses associated with the operation of the city’s wastewater treatment operations are paid. Fund balance represents the accumulation of prior period revenues minus expenses. The fund balance can be used in future periods to stabilize fluctuations in revenues, or during periods of greater than typical spending. Evaluating the fund balance (and the corresponding revenues and expenses) is a valuable exercise in that it provides insight as to trend (increasing or decreasing) and capacity (will the fund have adequate resources to pay future expenses?).

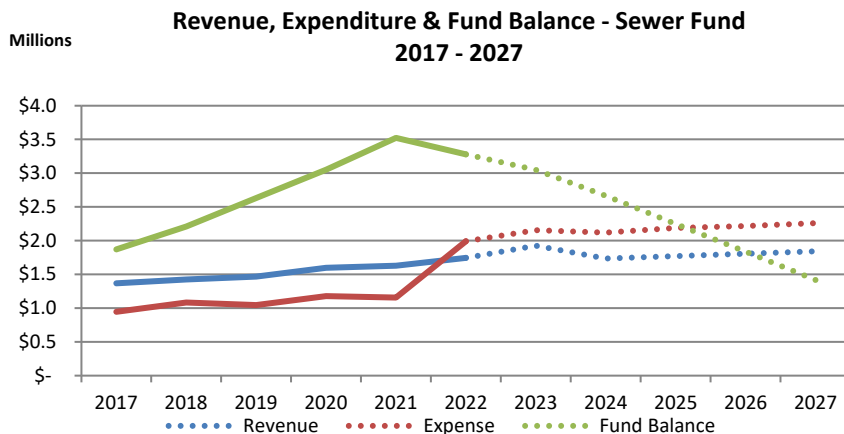


The chart above plots revenue, expenditures and fund balance since January 2017. The solid color lines represent actual numbers, and the dotted lines represent projections for the rest of the year. A trend line has also been added to the chart to smooth out the periodic ups and downs and provide a smoothed trend of the fund balance over the time horizon of the chart.

The fund ended 2022 with an unencumbered fund balance of \$3.10 million, which was \$1.59 million (105.22%) higher than year-end 2021 and was equal to 142.7% of FY 2022 spending (including carry over encumbrances). The fund ended 2021 with an unencumbered fund balance of \$3.38 million, an increase of \$653.2 thousand (23.96%) from 2020. In contrast, the FY 2023 budget projects a year-end fund balance of \$3.05 million, which equates to a reserve ratio equal to 141.54% of expenditures.

As you can see from the chart above, the balance in the Sewer Operations fund increased consistently from 2017 through 2021. Revenues have tracked fairly closely to, or exceeded, revenues over the years covered by the graph, resulting in an upward sloping fund balance.

Based upon current estimates of revenues and expenditures, the current projections call for the fund balance to decline annually over the next five years (see chart at the bottom of the previous page), with expenditures generally exceeding revenues. The fund is projected to end 2027 with a fund balance of \$1.42 million, or a ratio of 62.71%. This chart has been updated with the approved 2023 budget data through 2027.

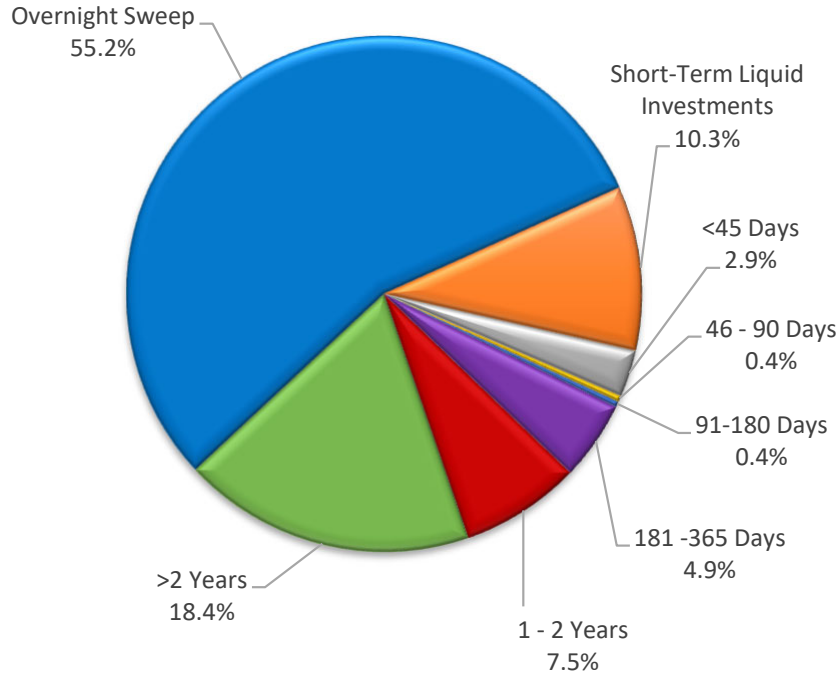

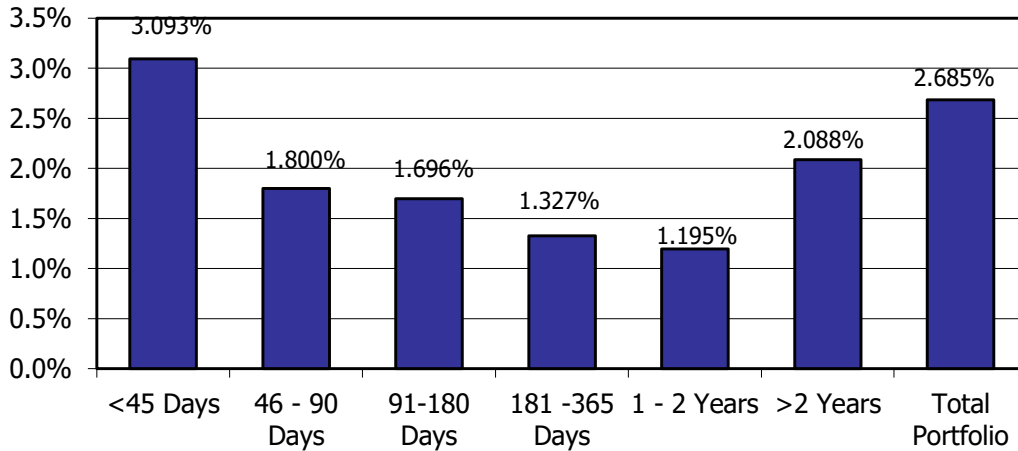

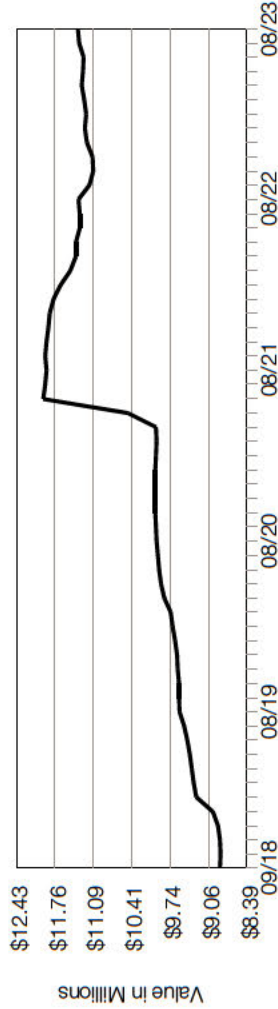

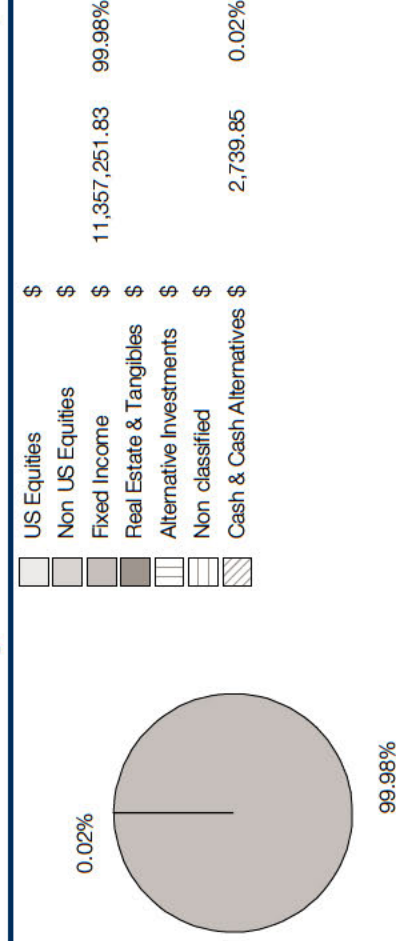
