



## CITY OF PATASKALA

### COUNCIL MEETING

August 21, 2023

The Council of the City of Pataskala met in regular session on August 21, 2023 at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Hite, Epperson, Dandurand, Hampshire, Galik, Lee -present. Walther – absent. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

#### **Discussion and approval of Consent Agenda matters**

**RESOLUTION 2023-067** - A resolution establishing and adopting the 2023 – 2025 pay matrix for non-collectively bargained employees for the City of Pataskala, effective for the pay period beginning on and after January 1, 2023.

**RESOLUTION 2023-068** – A resolution authorizing and directing the City Administrator to execute an agreement to purchase two (2) new police vehicles from Jim Shorkey Chrysler in Pennsylvania and have them equipped by Parr Public Safety Equipment.

**RESOLUTION 2023-069** – A resolution increasing Council Member's salaries and the Mayor's salary.

**RESOLUTION 2023-070** - A resolution consenting to the Ohio Department of Transportation's project to replace the Mink Street Bridge (SFN 4563743) in the City of Pataskala.

**ORDINANCE 2023-4452** First Reading An ordinance creating, establishing, and adopting the City of Pataskala Emergency Operations Plan.

Dandurand heard great things about the Street Fair, was not able to make it.


Epperson thanked everyone for the Street Fair and thanks to the Development Committee for the hard work on the screening.
