**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:**

Section 1: The amounts and rates, as determined by the Budget Commission in its certification, are hereby accepted as provided within the attached "Schedule A" and "Schedule B"


Section 2: The rate of each tax necessary to be levied within and without the ten-mill limitation is hereby levied on the tax duplicate of the City of Pataskala.
