



**RESOLUTION NO. 2023-082**

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH M.P. DORY COMPANY FOR REPAIR OF THE GUARDRAIL ON THE HEADLEY'S MILL BRIDGE (SFN 4563301)**

*WHEREAS*, the City of Pataskala maintains and improves the public roadways, bridges, and related infrastructure for drainage; and;

*WHEREAS*, the City of Pataskala recently was alerted, via a bridge inspection, that the guardrail attachments on the Headley's Mill Bridge (SFN 4563011) will need replaced within the next year; and

*WHEREAS*, the guardrail, located on one side of the bridge, failed. It is no longer attached to the bridge. This situation creates an unsafe situation for vehicle traffic on and over the bridge. It needs repaired immediately; and

*WHEREAS*, because the bridge inspection recommending that guardrail on both sides of the bridge be replaced, Council for the City of Pataskala wants to repair all the guardrail at this time; and

*WHEREAS*, M.P. Dory Company submitted a reasonable quote in the amount of Twenty-Five Thousand Eight Hundred and Twenty Dollars and No Cents (\$25,820.00) to replace the guardrail on both sides of Headley's Mill Bridge; and

*WHEREAS*, there are sufficient funds available within the 2023 budget to complete this work.


**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with M.P. Dory Company to repair the guardrail on the Headley's Mill bridge (SFN 4563011) in the amount of Twenty-Five Thousand Eight Hundred and Twenty Dollars and No Cents (\$25,820.00).

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
