CITY OF PATASKALA

ORDINANCE 2024-4463

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2024.

WHEREAS, Council previously adopted the Municipal Budget ("the budget") for the year ending December 31, 2024 (Ord. 2023-4457), and is authorized to amend the budget during the budget year; and

WHEREAS, during the development of the budget, the City Council department was overlooked, and no non-wage budget was developed; and

WHEREAS, the approved 2024 budget did not contain appropriations for expenditures by City Council, but funding is available in the carryover balance; and

WHEREAS, the Utility Department included in the 2024 budget the purchase of a new crane truck and a new utility truck; and

WHEREAS, the purchase price of the trucks with required accessories has increased since the budget was approved by Council, and the Utility Department now believes the cost for those trucks is approximately twenty thousand dollars (\$20,000.00) greater than the amount in the approved 2024 budget, and

WHEREAS, the Utility Director is requesting approval of an increase in appropriations of twenty thousand dollars (\$20,000.00) to complete the purchase of those trucks and their accessories; and

WHEREAS, the Headley's Mill bridge has been found to be degraded and in urgent need of repair; and

WHEREAS, Council for the City of Pataskala has expressed its' desire to move forward with the replacement of the superstructure; and

WHEREAS, the estimated cost of the aforementioned replacement is approximately three hundred thousand dollars (\$300,000.00); and

WHEREAS, funding for the replacement project is available from a combination of savings from the 2023 budget and from projects in the 2024 budget with reduced scope; and

WHEREAS, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2024 budget; and

WHEREAS, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall "make any expenditure of money unless it has been appropriated in such chapter."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED

THERETO CONCURRING, THAT:

Section 1: Council hereby authorizes an increase in the appropriations in the Executive & Legislative function in the amount of **twenty-seven thousand five hundred dollars (\$27,500.00)** from the **General Fund (Fund 101)** to pay expenses associated with the operation of City Council, as follows:

Section 2: Council hereby authorizes an increase in the appropriations in the Water Utility function, Capital Outlay object in the amount of **three thousand dollars (\$3,000.00)** from the **Water Capital Improvements Fund (Fund 602)** to pay the increased cost of purchasing a replacement crane truck (SWR-22-002) approved by City Council in the 2024 budget, as follows:

Section 3: Council hereby authorizes an increase in the appropriations in the Sewer Utility function, Capital Outlay object in the amount of **three thousand dollars (\$3,000.00)** from the **Sewer Capital Improvements Fund (Fund 652)** to pay the increased cost of purchasing a replacement crane truck (SWR-22-002) approved by City Council in the 2024 budget, as follows:

Section 4: Council hereby authorizes an increase in the appropriations in the Water Utility function, Capital Outlay object in the amount of **seven thousand dollars (\$7,000.00)** from the **Water Capital Improvements Fund (Fund 602)** to pay the increased cost of purchasing a replacement Transit truck (WTR-24-003) approved by City Council in the 2024 budget, as follows:

Section 5: Council hereby authorizes an increase in the appropriations in the Sewer Utility function, Capital Outlay object in the amount of **seven thousand dollars (\$7,000.00)** from the **Sewer Capital Improvements Fund (Fund 652)** to pay the increased cost of purchasing a replacement Transit truck (WTR-24-003) approved by City Council in the 2024 budget, as follows:

Section 6: Council hereby authorizes a decrease in the appropriations in the General Government function, Contractual Services object in the amount of **two hundred thousand dollars (\$200,000.00)** and an increase in the appropriations in the Public Service function, Capital Outlay object in the amount of **three hundred thousand dollars (\$300,000.00)** from the **Street Fund (Fund 201)** to pay the cost of replacing the Headley's Mill bridge superstructure and deck, as follows:
