### RESOLUTION 2024-007

Adopted January 22, 2024

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2025 INTERNATIONAL, MODEL MV607 SBA, TWO-WHEEL DRIVE, SINGLE AXLE DUMP TRUCK FROM RUSH TRUCK CENTERS, THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM, AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT**

***WHEREAS***, the City of Pataskala maintains public roadways during winter storm events; and

***WHEREAS***, the City of Pataskala owns and operates dump trucks for the purpose of roadway maintenance during winter storm events; and

***WHEREAS***, with the expansion of the City, including more roadway to plow, and the expansion of the department, with more personnel, an additional plow truck is needed to outfit all personnel with an operational plow truck; and

***WHEREAS***, the City of Pataskala needs to purchase a 2025 International, Model MV607 SBA, two-wheel drive, single axle dump truck ("Dump Truck"); and

***WHEREAS***, because the Dump Truck will be purchased from Rush Truck Centers, a selected contractor through the State of Ohio Competitive Purchasing Program, the City of Pataskala does not have to advertise and receive competitive bids; and

***WHEREAS***, the City of Pataskala reasonably estimates the purchase price of the Dump Truck will be \$127,115.90; and

***WHEREAS***, the City of Pataskala budgeted for the purchase of this Dump Truck as part of its 2024 Budget, as project PSD SVC-22-008.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City


Administrator to enter into a capital lease agreement for the procurement of a 2025 International, Model MV607 SBA, two-wheel drive, single axle dump truck.


Section 2: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract to purchase a 2025 International, Model MV607 SBA, two-wheel drive, single axle dump truck from Rush Truck Centers through the State of Ohio Competitive Purchasing Program, for an amount not to exceed One Hundred Twenty-Seven Thousand One Hundred Fifteen Dollars and Ninety Cents (\$127,115.90).

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
